Selectmen's Minutes

SELECTMEN'S MEETING MINUTES FOR JUNE 20, 2011

Selectmen Present: Wayne Rundlett, Doug Archer, Andrea Reichert;
Present: Stacie Rundlett, Bert Dyer, Terri Lamontagne, Brian Rundlett, Kip Poulin

Meeting called to order 6:30 pm.

Andrea motioned to accept minutes from June 5 Selectmen's meeting; Doug seconded and all were in favor.

Bert Dyer, interim assessor's agent, brought to the Boards' attention a Tree Growth violation that had occurred in 2008. He reviewed with the Board the State Statues regarding Tree Growth Laws. There was a brief discussion. The Board asked Bert to send a letter to the property owners regarding the Tree Growth violations, asking them to meet with the Board to discuss the matter further. Bert also briefs the Board on the assessing work and the status. The tax maps have been updated and Bert and Terri have started the field work that needs to be done.

Kip discussed with the Board that the options for purchasing fire truck for water. He found a truck that met the Board's prior authorized amount and his requirements in Florida. He reviewed expenses for retrieving the truck. There was a brief discussion about the matter.

Stacie discussed with the Board her findings after a conversation with the attorney at MMA regarding the County Commissioners ruling on an abatement request from Ronald Pinkham and the old Central School building.

There was a discussion about the Town Clerk's office and reporting issues involving the State of Maine Vital Statistics. She also briefed the Board on changes within the State of Maine Vital Statistics office and how it changes procedure in the Town Clerk's office.

The Board reviewed and signed Payroll and Accounts Payable Warrants.

Stacie discussed with the Board options for locking in fuel prices for the heating season of 2011-2012. The Board agreed for Stacie to call the School District to see who they might be going with this year. And then to make some calls to see pricing differences for heating fuel.

Stacie also briefed the Board about the town sign and putting it back up. Longer posts were ordered and deeper holes needed to be dug to ensure that it would not be blown over again.

The Board had a brief discussion with Brian about the informational meeting the Planning Board had on Wind Towers.

Stacie discussed with the Board the meetings she had with Douglas Marble and Peter Gardner dealing with the Transfer Station.

There was a discussion briefing the Board on the playground and the Recreation Committee. Currently, the Recreation Committee are working towards putting up a fence around the playground area next to the Fire Station.

Andrea motioned to adjourn the meeting, Wayne seconded. Meeting adjourned 8:10 pm.

SELECTMEN'S MEETING MINUTES FOR JULY 5, 2011

Selectmen Present: Wayne Rundlett, Andrea Reichert; Present: Stacie Rundlett, Ed Boyer, Duane Ricker, Kip Poulin, Gary Agren, Jamie Eck, Mike Denticio

Meeting called to order 6:32 pm by Andrea Reichert as Doug Archer was not present.

Kip discussed with the Board that the fire truck which was discussed at the last meeting was no longer for sale. It seems the Department who owned it decided not to sell it. So he is still searching for a truck to meet New Portland's water needs. He also discussed with the Board that the small generator that is behind the Fire Station appears to have been hit by lightning. Parts were ordered and one of the department members who works on generators was going to install the new parts to save money on labor. There was a brief discussion on putting in an insurance claim for the damages. It was decided to not do that as the repairs and parts were not that much more than the Town's deductible with the insurance company.

Gary gave the Board some pricing from Fine Line Paving for possible tarring projects throughout the community. There was a brief discussion on the proposed projects. There was a discussion on culvert projects on Hancock Pond Road and the slip line project on the Gilman Road. After discussions on the proposed projects the Board decided to table the matters until the next meeting. Gary briefed the Board on some gravel work that was being done throughout the town.

The Board reviewed and signed the payroll and accounts payable warrants.

Andrea motioned to update the Town's website with funding to come from the TIF account, Wayne seconded and all were in favor.

There was a discussion for the Town to participate in the InfoMe-Rapid Renewal with the State of Maine. Stacie provided some information regarding the matter to the Board members. This would allow residents to renew their vehicle registrations online with the State of Maine. Stacie pointed out to the Board members that one of the downfalls to this was the loss of the revenue from the Agent Fee collected when this is done at the Town Office. She informed the Board that it would provide a convenience to the Town's residents, and she needed to get more information on matter. The Board decided to table the matter until she could do so.

Stacie discussed with the Board the option to participate in a program that would allow residents to pay for transactions by credit/debit cards. This was approved in the past by previous Board members but has not yet been implemented due to scheduling issues. The current Board members agreed that if no costs would be incurred by the Town and the residents wanted this option to go ahead and try to get this active as soon as Stacie could schedule it.

There was a discussion regarding changing the Town's mailing address. Last year it was authorized to change from a post office box to a regular mailbox at the Town Office. The Board decided it was still in favor of that, and Stacie informed them that she was going to try and have that accomplished before tax bills were issued so there would not be any confusion where to mail tax payments.

Wayne brought before the Board a complaint made by residents exiting Chick Road onto Route 27. It was proposed to him to put up a mirror so it would be easier to see the oncoming traffic around the bend of Route 27. The Board discussed the matter and asked Stacie

to contact the Department of Transportation to see how to go about doing something to resolve the issue.

Andrea motioned for the meeting to be adjourned, Wayne seconded. Meeting adjourned at 7:24 pm.

Recreation Committee

Recreation Meeting was held July 20, 2011; Meeting started at 6:30 pm.

Members present: Jessi Campbell, Stacie Rundlett, Judi Wills. Selectmen Wayne Rundlett, and Planning Board member Brian Rundlett.

First discussion was the final planning for the playground. It was decided at the last meeting to use all the equipment that is in the field. The committee had looked at the equipment and found pieces that were missing. So, we are trying to find replacement parts. Jessi will call the company who makes this equipment and price the parts. It was decided not to use the soccer nets, due to space. These will be given back to the individuals who donated the equipment. The committee reviewed money available and decided to purchase a new swing set. (There was not one in the items donated.). The swing set was ordered by Stacie according to the requirements stated in the Playground Safety Handbook.

Measurements were taken to plan the placement of the equipment following the safety rules for spacing. The area was stacked out.

Next, we discussed the work that needed to be done and a time frame. Jay Luce was contacted to see if he was interested in digging the holes needed for the equipment. (He had said a year or more ago he would do this). Jay requested we marked where all the equipment would be going, mark the areas for digging. This has been done with what equipment that is there; we have to wait until the swing arrives to make sure we get measurements according to the size of the equipment. Each piece of equipment will be set into cement.

The construction plan for the playground will be done in phases/stages to make sure all requirements are being met. We are planning a work day for August 27 to move the equipment and pour the cement. We are also hoping to have ground fabric to cover over the area, followed by wood chips. This is the acceptable material in our playground handbook. The material will be the depth required for "fall factors" from the equipment. This sounds like a busy day, but the committee feels with the right lifting equipment and helping hands this can be accomplished. The committee is working on getting this all organized for that day, meeting at 8:00 am at the Fire Station / Community Room on the 27th of August. Next phase will be the fence that has been requested by citizens for the safety of children running out into the parking lot. There is a gravel pad in place for parking right next to where the equipment will be going. The fence will go around the entire play area with a gate at one end. At that end we hope to put a picnic table, benches, and trash cans. The fence will be purchased from a local business. A donation was made to the Recreation Committee to help purchase this fence; also, we have received money from community businesses and families to have a plaque with their names on a section of fence to help fund this purchase. The wood chips will be purchased from

a local company, which have the chips, that meet the guidelines in our handbook. The fire department has an interest in the basketball hoops to set up. More discussion will be held to determine if this is still something they want to do.

Discussion and plans for future events were held. We will be doing a Harvest Festival in October to go with the Scarecrow Contest. We are in hopes to have a few activities to draw people here and have fun. Also, the committee talked about the "wagon" ride singing car-olers. We would like to do this again in December. More discussion on these subjects will be held at our meeting August 10, 2011 at 6:30 pm at the Community Room. We have room for more people to join our committee, or just attend the meeting if you wish to share ideas. If you would like to suggest an idea, you are welcome to call Judi Wills or Jessi Campbell to discuss them.

Announcement

I want to take a little space here, to say Thank You to everyone who helped put the flags up in New Portland. This started with just a few flags during our Bicentennial to show our pride as a town and a country. People in New Portland chose to continue to raise the flags and many have supported the tradition. To have the freedom to have the flag wave and as citizens to raise it, in honor of all the soldiers (men and women) who fought and fight now for all of our rights and freedom. We stand strong as a community in doing this.

So, why is it a few people, choose to continue to destroy a symbol such as the flag, just because they can. In the dark of night when no one can see you. Three flags have been put onto the East New Portland Bridge and each one has been destroyed. Flags cut off the pole, then when the flag was replaced the pole snapped off and everything thrown into the river. So a stronger pole was made, same thing happened again. This year we made the pole with heavy metal, raised it a little higher. Then the morning on July 4 the pole was twisted and bent down, and the flag cut off because they could not remove it from the pole. (It took more than 1 or 2 people to do this.)

I wonder if you know what the flag is a symbol of? Do you know how you remain being free to make choices to live, work, not work or play? If you have that much time on your hands become part of the town and help us keep the flags waving. Take the time to help someone in the community that could use a hand up. Volunteer in the community, your energy is needed in many places. You have the choice to do what you want, but please allow the citizens in New Portland, our choice to support our men and women who choose to keep this town and country free.
