Selectmen's Minutes

Selectmen's Meeting Minutes - April 18, 2011

Selectmen Present: Doug Archer, Andrea Reichert, Wayne Rundlett;
Present: Stacie Rundlett, Brian Rundlett, Robert Whitten

Meeting called to order 6:40 pm.

Selectmen reviewed minutes from meetings April 5, 2011. Doug motioned to accept the minutes as written. Andrea seconded and all were in favor. Mr. Whitten asked if all the meeting minutes have now been reviewed and accepted to date. The board confirmed that they were and offered a written copy of meeting April 5, 2011 to him as well.

No department heads were present.

The Selectmen reviewed and signed warrants #12 (payroll) \$7,545.11 and #13 (accounts payable) \$26,668.94.

Stacie presented to the board a draft version of a job description for the Assessor's Agent position for them to review. There was a discussion on options for the job description. The Board gave Stacie a few changes to make to the description for requirements.

Stacie also presented to the board a draft version of an ad to publish for the Assessor's Agent position. The Board discussed options for the ad and agreed to put in *New Portlander*, on the website and in *The Irregular* and *Morning Sentinel* with a deadline to receive applications by for this position of May 12, 2011 at 7:00 pm.

Stacie presented to the board a draft version of warrant for special town meeting scheduled for May 16, 2011. The board reviewed the warrant and articles on it. There was a lengthy discussion regarding an article to repeal Article 7 that was passed at the 2011 Town Meeting and replace it with an article more specific. The board felt that it is important to honor the intent of the article that was passed, but they were concerned about how this article's wording would affect their authority to expend funds designated in special accounts. Mr. Whitten, member of the Concerned Citizens Committee that presented this article to the board, discussed his thoughts on the actual intent of the article. It was clarified that this change would not involve expenditures of surplus, as it is a State law that money from surplus cannot be spent without authorization from a town vote.

There was a discussion regarding the fire department's need of a truck to haul water.

There was a discussion on the status of the Comprehensive Plan.

Doug motioned and Andrea seconded; all were in favor to authorize Stacie to sign a Release of Bond for Gilbert Taylor.

The board reviewed and signed an abatement request for Brian Emery in the amount of \$397.25

Stacie presented to the board a draft version of a Notice of Tax Sale by sealed bid. The board authorized Stacie to publish this notice with the bids to be opened at 6:15 pm on May 16, 2011.

There was a brief discussion regarding the lawn that was damaged on the outskirts of the parking lot of the Town Office and Community Library. The board decided to table the matter until the May 3 Selectmen's Meeting to allow time for all board members to view the damages.

Andrea discussed that someone needed to contact the printer to insure that it was printed in a more timely fashion so that the *New Portlander* could be mailed and delivered before the first of any given month. There was a brief discussion of the protocol Stacie was to follow, and Andrea was to contact Dallas regarding this issue.

Robert Whitten presented questions to the board regarding the status of the Municipal Advisory Committee, the Comprehensive Plan and the possibility of the board changing from a three member to a five member. The board informed Mr. Whitten that currently there were only two MAC members and to their knowledge no one else has contacted the town clerk or any other town official about their interest in being on this committee. They discussed with Mr. Whitten that they have not moved forward with trying to change from a three member board to a five member board, as there was more research to be done. Andrea briefed Mr. Whitten that she had started reviewing the recommendations from the various State agencies that were made to bring the Comprehensive Plan compliant to State standards, but it was a work in progress. Mr. Whitten also discussed with the board his concerns of the roadwork that has been done in the past on the Middle Road and the aesthetics of the road. There was a discussion regarding his concerns and the right of way of the Middle Road. Mr. Whitten stated that the right of way was only 50 feet. He was concerned about the ditching that has been done or that might be done in a particular area of the road and felt the Town would be liable if any ditch work done by the Town caused any stonewalls to be disturbed. The board felt this issue should be discussed more with Gary present.

Meeting adjourned at 8:10 pm.

Selectmen's Meeting Minutes - May 3, 2011

Meeting called to order 6:33 pm.

Selectmen reviewed minutes from meetings April 18, 2011. Andrea motioned to accept the minutes as written, Wayne seconded and all were in favor.

Kip discussed with the Board of Selectmen the options for selling the 1988 White Mack truck. Andrea motioned to put the Mack truck out to bid with a minimum bid of \$5,000. Wayne seconded and all were in favor. It was decided to put an ad in *The Irregular*, on the town's website and in the June *New Portlander*. The Board of Selectmen discussed with Kip options for water trucks. He will continue to look until a good option becomes available.

Gary discussed with the board his concerns about a fence close to the road on the Middle Road. He reviewed State statutes with the board concerning fences and right of ways on the road. There was a brief discussion and the board asked that Stacie contact the landowner to remove this fence. Gary discussed a request

from Tom Dodd to set a culvert in his driveway. Gary said he would not recommend doing this. There was a brief discussion and the Board of Selectmen agreed with this recommendation. Gary said he would notify Tom of this decision. The board briefed Gary about the concerns from Robert Whitten, brought to the board at the last meeting. There was a brief discussion about the ditching and the aesthetics of the Middle Road. Stacie shared with the board her findings on the right of way for town roads, being that they are listed as four-rod roads. It was decided that Gary and Stacie would communicate about the locations of his roadwork. He briefed the board of some grading that would be taking place with the warmer weather. Duane Ricker questioned a ditch being put in on New Portland Hill Road. There was a discussion about the costs of doing that.

Bert discussed with the Board of Selectmen a request for abatement for Virginia LaNoce. After a brief discussion Andrea motioned to abate the 2010 Real Estate taxes in the amount of \$2,817.50. Doug seconded and all were in favor. Bert and Stacie discussed with the Board of Selectmen a possible proposal from Clyde Dyer to submit a proposal for contracting the town's assessing instead of submitting an application as an employee. The board was willing to entertain a proposal with details of the work that would be done. Bert briefed the Board of Selectmen his status for the assessing work. Doug offered his assistance.

Becky brought to the Board of Selectmen, Warrant and Notice of Election Calling Maine School Administrative District No. 74. Budget Validation Referendum.

Payroll Warrants #14, and #15 (\$493.40/\$5,232.26) and Accounts Payable Warrant #16 (\$4,892.66) were reviewed and signed.

The proposed articles for the Special Town Meeting Warrant were reviewed and discussed. The board asked Stacie to change some of the wording on Article #4.

There was a brief discussion about the drainage of driveway near the library and options to fix. The board voted to find someone to fix the lawn areas so they could be mowed and possibly next year addressing the issues of fixing the drainage problem at next year's budget time. The Board of Selectmen asked Stacie to ask Charles Costello and Jay Luce to submit proposals for the lawn work that needs to be done before any work is done.

The selectmen asked Stacie about the status of the town signs being repaired. Stacie stated she would get in contact with Alex Dunham who was in charge of getting the materials to do the repairs. Andrea also brought up the town sign out front of the property and that it needs to be either placed in a different location or reinstalled with better material. She wanted the other board members to think about options to be discussed at another time.

There was also a discussion about the generator that was donated to the town two years ago. Since it needs a lot of work in order for it to operate properly, it was proposed that the town sell it by sealed bids when the 1988 Mack Truck goes out to bid. The selectmen asked Stacie to contact Somerset County to make sure they were authorized to do this since the generator was donated to the town.

Meeting adjourned 8:05 pm.

- One 1988 Mack R688ST Truck, VIN# 1M2N187Y6JW025167. White in color. Mack 350 9 speed manual transmission. Current mileage is 0930. Front two seats only. The minimum bid for this vehicle will start at \$5,000.
- One 2003 Onan Generator, Model# 47GGFE with 43 hours of operation. The minimum bid for this machine will start at \$5,000.

Both the 1988 Mack and the 2003 Generator can be seen at the New Portland Fire Station, around the back side of the building. Each bid must include the bidder's name, mailing address and phone number and must be accompanied by a deposit in the form of a certified check or money order, in an amount equal to or greater than 10% of the bid price. Each successful bidder's deposit will be credited to the total purchase price for that item. Deposits will be returned to the unsuccessful bidders. Any bid which does not contain the proper deposit will be rejected. All sales will be as is where is.

In the event that a successful bidder fails, for any reason, to complete the purchase in the time stated, the bid acceptance is void and the bidder's deposit shall be forfeited to the Town. The Board of Selectmen may thereafter negotiate a sale of the property with any or all-unsuccessful bidders.

I would like to say a big thank you to Andrea Reichert for taking the time in her busy schedule to try and find answers to all my questions concerning the numerous mistakes that were made with our property tax bill this year. This resulted in Mark's name being incorrectly printed for 2010 delinquent taxes.

The town manager stated that I was mailed three bills, and I have never received any of those bills. The bills should have originated at the same post office, as my post office box is in the New Portland Post Office for the last twenty years.

Why the town manager didn't use the map lot and property number when escrow money was paid electronically by the bank, having nothing to do paperwork-wise with the actual property owner or any town account number, as the bank gives a list to the town for property it is paying for by the name, amount, and map lot property number as it has always been done, and there has never been a problem before?

Why the town, after incorrectly crediting my name and money paid to a piece of property I no longer own, would then accept more money on the same piece of property by the actual current owners after it had already been paid for, even though the amounts didn't match?

Why it finally boiled down to my bank not writing the town's account number, that it didn't have and never has had, on a lump sum check for all escrowed New Portland property owners, when the bank clearly gives all information it is required which is name, amount, map lot and property number, as I was under the impression that when any money is paid by someone on a tax bill for a piece of property that any and all the town clerk's would match the amount paid, and the map lot and property number for correct payment on the correct piece of property?

Thank you, Andrea, for trying your best to answer all these confusing and difficult questions. Your knowledge and understanding is greatly appreciated.
