Selectmen's Minutes

MINUTES OF SELECTMEN'S MEETING FOR AUGUST 15, 2011

Selectmen present: Wayne Rundlett, Andrea Reichert, Doug Archer; Present: Stacie Rundlett, Bert Dyer, Terri Lamontagne, Brian Rundlett, Kip Poulin, Richard Ames, Michael Kankainen, Laura and Howard Dunham

Meeting called to order 6:40 pm.

Doug brought to the board's attention some information on the state statutes regarding tree growth laws. There was a discussion on the tree growth notifications. There was a brief discussion on the tree growth violation issue that happened in 2008. Terri discussed the law that complies with what had occurred regarding the tree growth violation in 2008. There was a brief discussion. Doug then reviewed the penalties written by the statutes. State statues require that a minimal penalty has to be imposed.

During the discussion the board members questioned the assessor's agents about the changes to the statutes. Bert discussed with the board members the formula of what the minimal penalty would possibly be in this matter. There was further discussion on the penalties and which should be imposed. The board members and assessors agents both agree that there is no other option but a penalty for the violation. Board members ask about the minimal penalty and which formula to use. The town is required to impose minimal penalty that the assessor's agents have provided minus the taxes. Doug motions to assess penalty according to law, which is the minimal penalty for not complying with tree growth plan. Assessor's agents will figure the formula. Andrea seconds. All were in favor.

Stacie discussed that the culverts have been delayed due to the delivery of the culverts. They should be in by this week, and it will delay project due to the rain. Stacie notified the board members that the signage would be two to three days in advance of closure for the Gilman Pond Road. Board members were asked what they wanted Gary to do with the money that was set aside for Hancock Pond Road. There was further discussion on this. Paving projects, changes in Fine Line paving estimates. Quote was \$67, 200, now is down to \$64,400.

Quote includes all except Hancock Pond Road. Bruce Manzer quoted \$60,995 which did not include everything which changes Manzer's quote to \$63, 580, as the quote did that Fine Line had given. There was a brief discussion on this. Wayne motioned for Fine Line paving to do the jobs. Andrea seconded and all were in favor.

Kip updates the board on work that is being done and needs to be done on the fire trucks. Kip updated the board about parts they ordered for the department's generator.

Doug motioned to accept the minutes from the meeting on August 2, 2011. Wayne seconded it, and all were in favor.

Board members reviewed and signed all warrants.

Board members discussed Kingfield Water District's offer to purchase the generator. Doug motioned to accept Kingfield Water Districts offer of \$2100.00. Wayne seconded, all were in favor. Brian suggested that the board of selectmen consider reducing the amount of the generator to what they had invested in it so far. Doug rescinds his previous motion. Wayne seconded it. Doug motioned to reduce and sell the generator for \$800.00 to the Kingfield Water District. Wayne seconded it; all were in favor.

There was discussion on when to hold the next transfer meeting. Stacie reported to the board starting August 19, 2011 the Transfer Station is open Fridays from 12:30 to 4:30 pm, and the 2011 Household Hazardous Waste Collection Day is set for Tuesday September 9, 2011 from 9:00 am to 1:00 pm.

There was discussion about the Town Clerk's office regarding reporting and upcoming training. Judi updated to board members on the playground project.

Meeting was adjourned at 8:18 pm.

SELECTMEN'S MEETING MINUTES SEPTEMBER 6, 2011

Selectmen Present: Douglas Archer, Wayne Rundlett, Andrea Reichert Present: Stacie Rundlett, Richard Ames, Gary Agren, Kip Poulin, Duane Ricker, Ed Boyer, Bert Dyer, Terri Lamon-tagne.

Meeting called to order at 6:40 pm.

Terri updated the board on who was contacted regarding the tree growth violation. Mike Rogers from the State of Maine reported to the assessors agents that Richard Ames has 120 days to be in compliance, and he was sent a letter on June 21, 2011; he has until October 19, 2011 to get in back into tree growth, or he will have to pay the full penalty. Richard Ames accepted what the plan is to be.

Kip updated the board about an offer on the white Mack. There was an offer of \$2500 for the white Mack. Andrea stated the bill of sale should specify "as is, where is and no warranties". Andrea motions to accept the offer for white Mack; Doug seconded; all were in favor. Kip asked if the money that came from the generator could go towards lettering the new fire truck. All were in agreement to that.

Gary updates the board on the road projects. The culvert on the Gilman Pond Road was done. The project ended up costing less than what he had anticipated. There was not any road damage from hurricane Irene, just a lot of surface gravel lost. To replace surface gravel throughout the whole town would cost approximately \$22,400. The roads that were highly damaged were George Cole Road, Atwood Hill Road, Bennett Hill Road, Freeman Ridge Road, Millay Hill Road. Andrea asked if there was any relief coming from FEMA for damages done during the storm. Gary replied no because Somerset County was not declared a disaster area. The grader has been going around starting some road clean up. There was a brief discussion about his budget. There was more discussion on roads and culverts. There was a discussion about the repairs that needed to be done on the Hancock Pond Road. Gary mentioned to the board about a grader for sale from Farrin Brother's, asking price is for \$90,000.

Stacie confirmed with the board members that it was OK for Alicia Wills to do the last couple of mowing jobs that are needed.

There was a brief discussion on the transfer station meeting. Andrea makes a motion to accept the minutes from the August 15, 2011 selectmen's meeting, Wayne seconded, all in favor.

There was a brief discussion about the playground.

Andrea motioned to adjourn the meeting at 7:36 pm; Doug seconded; and all were in favor.
