Selectmen's Meeting Minutes for September 21, 2015; Selectmen Present: Wayne Rundlett, Mike Senecal, Andrea Reichert; Present: Stacie Rundlett, Becky and Gilbert Taylor, Ron and John

Andrea called the meeting to order at 6:32 pm.

Selectmen reviewed minutes from the previous meeting. Andrea motioned to accept as written with a spelling correction, Wayne seconded and all were in favor.

Board members reviewed and signed A/P and payroll warrants.

Mike was called and placed on speaker phone; so, he could hear the proceedings of the meeting. Andrea relayed to Mike on the phone the amounts of the warrants and brief description as to for what each was. Wayne briefed everyone on the new fire truck and how far along they were on getting the truck in service. Wayne briefed everyone on the pump testing that was going to take place on Friday.

Andrea relayed that there was only one item on the agenda for the Selectmen, which was the signing of the Snow Plow Contract. There was a discussion regarding the installment amounts. There was also a discussion regarding contractors carrying general liability insurance as well as insurance on their vehicles. The board members and Gilbert came to an agreement on the amounts of the installment after the initial installment of \$50,000 in October. November and December payments would be in the amount of \$26,000 each. And January through April would be \$30,750. That would be a total of \$225,000 for the season. Andrea, Wayne and Gilbert signed the Snow Plow Contract. Stacie witnessed their signatures. There

was a brief discussion about the screening process and a time for the selectmen to check out this process.

Wayne motioned to adjourn, Andrea seconded. All in favor.

Meeting adjourned at 6:54 pm.

Andrea called the meeting to order at 6:34 pm.

The selectmen started the meeting with public comments, questions or concerns about the General Assistance Ordinance for 2015-2016. Stacie advised the board that Somerset's figures have increased slightly, per the state's guidelines to determine eligibility for general assistance. There was a brief discussion. Andrea motioned to accept the new guidelines, and Mike seconded and all were in favor.

Selectmen reviewed minutes from the previous meeting. Mike motioned to accept them as written, Wayne seconded and all were in favor.

Kristen finalized paperwork with the board member's regarding the freedom of information act. Kristen updated the board on voting information and dog licensing process. She updated them on all of the recent training that she has done for the clerk's office through vital statistics and the Bureau of Elections.

Gary updated the board on work he has left to do. He updated them on the last storm and the beaver damages in town.

Kip discussed the possibility of putting in a dry hydrant on Gilman Pond Road. There was a brief discussion regarding this. He updated the board that currently there had been 57 calls, payroll is around \$5200. The new truck is in service; there are just a few things to finish up with that. Turn out gear has been ordered. Traffic arrows will be ordered. He briefed the board on pump testing that had been done recently. There was a discussion on making arrangements to be put on the agenda for the Somerset County Commissioner's meeting for November 18 to discuss mutual aid with Highland/Lexington.

Brian updated the board on an upcoming public hearing for the Planning Board. It is just for an additional permit

that CMP needed to submit for a repeater that they did not remove. It is the same as the others that have been permitted, just cleanup work from the previous permits.

Judi shared with the board the Comprehensive Planning Boards findings from the comprehensive survey. The majority of the comments from the survey questions covered revitalizing the West Village. She will leave a notebook at the town office so they can be viewed by the public if asked. There was a discussion regarding the questions, comments and suggestions on how to finalize the Comprehensive Plan.

The board talked to Gilbert regarding his progress on sand/salt piles and his preparation for the season.

Terri shared with the board the two abatement requests that had been submitted. Lewis Wills requested \$1000 in valuation/ \$17 in amount to refund, due to town's data showed more acres than they have. Mike motioned to grant the abatement, Wayne seconded and all were in favor.

Polly MacMicheal requested \$16,800 in valuation plus depreciation. Terri discussed her findings regarding her assessing the property at 100% complete. Polly states the property is only at 79%. There was a discussion regarding this request. The board asked to see the TRIO figures based at the 91% that is on Terri's completion form she used when she went out to the property. Andrea motioned to table the matter until the next meeting. Terri asked if it could be moved to the first meeting in November. Mike seconded and all were in favor.

The board reviewed and signed payroll and accounts payable warrants. Stacie briefed the board regarding a property in the West Village and the status of permits required. There was a brief discussion regarding current ordinances and the enforcement of them. There was a brief discussion regarding public boat launch possibilities.

Judi updated the board regarding the upcoming Fall Festival being put on by the Recreation Department and the Library on October 24 from 11:00 – 3:00 pm. There was a brief discussion regarding a Trunk or Treat that some community members were doing in the Community room area parking lot. October 31 from 3:00 – 5:00 pm.

There was a discussion regarding another community supper. It was decided to be on December 6. More plans to follow.

Meeting adjourned at 7:58 pm.

## **Comprehensive Planning Committee**

New Portland Comprehensive Plan met on October 5, 2015. Members present: James Heichel, Barry Turcotte, Alison Thayer, Bob Whitten, Stacie Rundlett, Marilyn Gorman and Judi Wills.

At the previous meeting the surveys that were sent to all residents and land owners were reviewed. We started with dividing the surveys between each member. We started to record all responses from surveys. Members read the answers and a person recorded and tallied responses. After an hour and 30 minutes we had covered up to question 5 on all returned responses. This was a tiring and long evening.

The surveys were then reviewed by one person, recording responses to each question into a notebook. This took a few hours a night until completed. The responses were then entered into a blank survey questionnaire under each question. This was completed for the meeting on October 5. Each member of the committee reviewed the completed questionnaire and discussion was held.

The purpose the survey was to gather ideas on what residents wanted or felt needed to be changed or improved. It was a chance for residents to give us their

views and suggestions. Some of the surveys did have these things in place, others told us what was missing and what they wanted to have done. Many of the responses on surveys were to improve the West village and the homes and to have businesses in town, a gathering place for people so they can socialize with neighbors. Some wanted a school in town again. One of the questions asked citizens if they would join a committee to help with activities in the town. We had 38 no's, 11 yes, 14 not able, 10 maybe and 1 yes with a phone number. We received 87 surveys back, 8 were blank, and a number of the surveys only answered one or two questions.

The committee's task now, is to build a comprehensive plan with future possibilities for the citizens of New Portland to decide. The planning requires outlines of steps on how to achieve the changes that were decided. The Comprehensive Plan is not a zoning ordinance, nor is it a law. It is an advisory document setting out the community's goals for the future and the policies and programs necessary to move the town in the direction of its goals. It is a foundation on which to build the town's land use controls and a road map that can be used by the town's elected and appointed officials to steer the town in an agreed-upon course.

The Comprehensive Plan needs to be submitted to the State of Maine to be eligible to apply for grants, funds or other financial support and to help the town meet its goals. This is very important to this town to help development and future needs. Respectfully. . .
