## Selectmen's Meeting Minutes for September 18, 2017

Raymond called the meeting to order at 6:30 pm.

The Board of Selectmen reviewed the minutes from September 5, 2017. Wayne motioned to accept them as written and Raymond seconded, all were in favor.

Kristen asked the Board of Selectmen if the town would pay a \$95 fee for a course which would enable Kristen to have enough credits to become a State of Maine Certified Town Clerk. There was a brief discussion, then all members agreed that they were in favor of doing this. Mike Senecal motioned to pay for this course, Raymond seconded, and all were in favor.

There was a discussion regarding CMP and antennas which have been put up throughout the town without pulling a Wireless Telecommunications Permit through the Planning Board. This would be the third time this has happened, and this time the representative for CMP has stated they do not feel their antennas meet the definition of an antenna which is described in the Town of New Portland Wireless Telecommunications Ordinance and would not be applying for a permit on these installations. The Planning Board and the Board of Selectmen had a discussion on this matter. Raymond motioned for Stacie to contact the town's attorney on this matter. Wayne seconded, and all were in favor.

Mike Malesky updated the board that he would be working on the survey for the Wire Bridge Park project in the upcoming week.

Brian Rundlett updated the board members on fire calls. There was a brief discussion on the recent fire call that was at the Wire Bridge.

Mike Senecal updated all in attendance that there would be a Sand/Salt Shed meeting held on October 11 at 6:30 pm. There was a brief discussion regarding a culvert issue on the Hancock Pond Road.

Meeting adjourned 6:58 pm.

## Selectmen's Meeting Minutes for October 3, 2017

Selectmen Present: Wayne Rundlett, Raymond Poulin, Michael Senecal (absent); Present: Stacie Rundlett, Mike Malesky, Dallas Landry, Brenda Stevens, Judi Wills, William Serafino, Ron Lindner-Demers, John Demers-Lindner, Gary Agren, Becky and Gilbert Taylor.

Raymond called the meeting to order at 6:30 pm.

The Board of Selectmen conducted a public hearing regarding the 2017-2018 General Assistance Ordinance. Stacie noted the increase in allowances that is governed by the State of Maine in this ordinance. There were no questions. The Board of Selectmen reviewed, Approved and signed this ordinance.

The Board of Selectmen reviewed the minutes from September 18, 2017. Wayne motioned to accept them as written and Raymond seconded, all were in favor.

Gary Agren updated the board on status of work to be done. There was a brief discussion regarding the Hancock Pond Road. Gary discussed with the board his suggestion of grinding the remaining pavement on the Hancock Pond Road. He received a quote for \$4200. Raymond and Wayne agreed with this proposal. Gary updated the board on a tire issue on the grader. Raymond briefly asked about the rock issue on the Hancock Pond Road that has been brought up previously. Gary would look into having the rock removed. Stacie updated Gary on a request for calcium on Hancock Pond Road. Depending on the weather later in the week he would take care of it.

Kip Poulin discussed with the board a proposal from ME DOT regarding a dry hydrant on Meadow Brook Road. He updated the board on the calls. He discussed his concerns with the board with an ongoing issue with Highland Plantation and the mutual aid, or lack of with aid from them. He requested the board consider putting in a request to the officials in Highland Plantation to discuss these issues.

Mike Malesky presented to the board two abatement requests. There was a brief discussion regarding these requests. Wayne motioned to accept the abatement requests, Raymond seconded, and all were in favor. 1. Raymond Brown- \$137.83; 2. Thomas Bossie- \$166.22. Mike presented a copy of the MVR to the board members for them to review. He would like them to sign it at the next meeting so that he can get it into the State of Maine in a timely fashion. He will get a copy to Mike Senecal as well.

Judi Wills presented a copy of a draft policy for the Recreation Committee. This is just a draft the committee has been working on and would like input from the Board of Selectmen.

Stacie presented A/P and payroll warrants to the board. The warrants were reviewed and signed. She updated the board on the status of the CMP and Wireless Telecommunications Ordinance. At this point it is just in the beginning stages of communications. She will keep the board updated when any additional information arrives. She reminded the board that the office would be closed the next two days for training. And the office is scheduled to be open Saturday 8:00 am to noon but closed again in observance of Columbus Day on Monday, October 9.

Gilbert Taylor relayed to the board that his sand/salt pile was up and ready for them to inspect.

Brenda Stevens asked what the scope and the costs for the survey which was done on the Hancock Pond Road. Stacie relayed she did not have the information on the scope of the survey, and the costs were around \$2200. She would have to look back in the warrants to get the exact price as she didn't recall from memory. Gary relayed what he had asked Sackett & Brake Survey, Inc. to include in the survey. Brenda asked if any of this was in writing, and it was stated to the public it was not in writing. Brenda noted her concerns about that. She also brought up her concerns regarding the beavers on Hancock Pond Road. There was a lengthy discussion regarding this and information that was provided to Dallas as well as information on the matter that was provided to Gary. Dallas Landry relayed his concerns as well and how it was all affecting the water lines. Raymond stated that he would contact Chuck Halsey about the issue and see what information he could get on the matter.

William Serafino asked the board about the much-needed improvements to the internet service here in New Portland. There was a brief discussion regarding the information that he was told by TDS and Spectrum. Stacie informed William she has contacted many people regarding this matter. And it boils down to all those she contacts relaying that the town of New Portland would need to invest 100's of thousands of dollars to upgrade our current lines or have Spectrum install more service than the few that they currently have in the North Village.

Raymond and Wayne both stated that they would go and inspect the sand/salt pile.

Meeting adjourned 7:13 pm.

## **RSU 74 / School Board**

---

The October school board meeting was held at the Embden Community Center.

Minutes: The minutes of the September Board Meeting were approved.

Proficiency Based Education Presentation: Brian Twitchell showed a video to the board. The video discussed Proficiency Based Education. The video emphasized that with PBE student learning and assessment can be more personalized.

Students have multiple ways to demonstrate proficiency.

The board raised questions about PBE. Some standards were written several years ago, and a board member wanted to know if those standards were still in use, or if they had been revamped. Mr. Twitchell said that over time, as the state has given more guidance, it has been determined that some of the standards were not sufficiently rigorous. Those standards have been revised or replaced. In general, there seemed to be more revision of math standards than English standards.

Another board member expressed skepticism of PBE. He worried that PBE was less about students reaching proficiency than it was about students being just passed along. Mr. Twitchell said that goal was for all students to be proficient.

A board member asked if all students were required to meet the same standards. Mr. Twitchell said all students must meet the same standards, though they are allowed to meet the standards in different ways.

Finally, one board member asked what school boards or individual board members could do if they were opposed to PBE. It is state law. Mr. Tracy said that the board as a whole could approve a resolution expressing opposition to PBE and that sentiment would be relayed to Augusta. Individual members were free, he said, to contact their state legislators.

Bus Warranty: Recently, the board purchased two new buses. At the last board meeting there was much discussion as to whether or not an extended warranty should be purchased. Cliff Chase from O'Connor spoke to the board about this. His recommendation was not to purchase the warranty. The board voted against the warranty purchase.

Superintendent Report: Mr. Tracy did not have much to add to the report which he had Submitted to the board members, but he did discuss the results of a recent survey that students in grades 6-12 were given the opportunity to take. The After School Participation Survey sought feedback as to what the barriers might be that prevent students from participating in extra-curricular activities. The most common responses as to why students didn't participate involved lack of transportation, unhappiness with coaches, and perhaps students were interested in an activity that RSU 74 did not offer. Students who did participate in extra-curricular activities said that they loved the activity in which they were involved, wanted to be active, and liked the coach. There was much discussion surrounding this topic. A next step will involve collaboration between the 6-12 athletic director, town rec departments, administrators, teachers, parents, and coaches.

Elections: Maurice Langlois and Stacey Robinson to National Honor Society advisors.

Appointments: Andrew Ferrari - MLTI stipend, Chuck Glidden - CHS jv boys' basketball coach, Luke Tewksbury - CCS boys' basketball coach, Erik Carey - CCS girls' basketball coach

Resignation: Kasey Hiltz - 4th grade, CCS

Admin Reports; Tim Richards told about the happenings at CHS. There will be a blood drive on October 10 The Boston college trip will be on November 1 and 2. 27 students are taking dual enrollment courses from KVCC, UMPI, and UMFK. Katrina Mason is a semi-finalist for the National Merit Scholarship. One student travels to Madison High School

for band. CHS seniors fundraised and cleaned up at the New Portland Fair. JMG students will attend an overnight conference on October 18-19.

Tom Desjardins said he is thrilled with all that is happening at CCS. There are 264 kids in grades k-8. He invited the board to visit CCS, where he said work is ongoing with PBIS. He said that he has tried to set very clear expectations. An eighth grade Huts and Trails trip will take place next week. He has been very impressed with the effort of the sports teams, and he is very pleased with the band and chorus students under the direction of Dan Gilbert.

Jean Butler said that first month at GS and Solon has been very busy with Open House, a spaghetti dinner at GS, Children's Stage Adventures at Solon, and various field trips. Mike Tracy said he attended the Children's Stage Adventure performance at Solon, and he was quite impressed.

Scott Hall had nothing to add to his report.

Nikki Richardson said the first month has been filled with arranging schedules and getting contracted services in place. RSU 74 is undergoing a special ed audit this year, and Nikki said that Bonnie Atwood has been a valuable resource. The number of students identified for special ed services has dropped from 144 to 141. Statewide 17% of students are identified, and in RSU 74 23% are identified. One board member commented on the challenges that special ed staff must face at times. Nikki commented she works with a group of wonderful people.

Lorie Agren said things are running a bit more smoothly than when the year began. Emergency lights should be up and running at Solon by next week. The Solon freezer should be running by Friday.

Committees: The Facilities and Grounds Committee met on September 13. They discussed the CHS storm drains. Some outdated custodial equipment needs to be replaced. Cracked concrete, tile, and carpet issues were discussed.

The Library/Technology Committee met on September 20. Current standards, Synergy, laptops for students in grades 4-12, and the k-3 mobile laptop carts were on the agenda.

Also in September, the board's ad hoc collaboration with RSU 59 and Bingham committee met. Earlier in the day, Drummond Woodsum (school legal firm/representatives) had presented to school districts on the topic of regionalization. At the ad hoc cmte meeting, it was emphasized that if RSU 74 goes the route of regionalization, we should proceed cautiously. Sometimes when regionalization agreements are entered into, it can be very difficult to withdraw later on.

Citizens: Nobody spoke.

JMG Trip: The board approved an overnight JMG trip on October 18-19.

Purchase of two low speed buffers and a wet vac attachment: The purchase, not to exceed \$2,000, was approved. New equipment was needed, especially after some of the existing equipment caught fire during usage.

School Calendar Change: The board took did not express any opposition to Mr. Tracy's plan to remove a workshop day in exchange for teachers doing parent conferences beyond school hours as has been done in the past.

Purchase a Fuel Tank to be placed at CHS: The tank, which

will not exceed \$2,000, was Approved. This will be paid for with QZAB funds.

CHS Boston Trip: The board Approved the CHS college trip on November 1 and 2. Students will visit SMCC, Brandeis, Stonehill, and Salem State.

Negotiations Update: The board's bargaining team will meet with the support staff bargaining team on October 12. They will undergo a joint interest based bargaining training.

Adjourn: The meeting ended at 7:36 pm
