## Selectmen's Meeting Minutes for October 16, 2017

Mike Senecal called the meeting to order at 6:30 pm.

The Board of Selectmen reviewed the minutes from October 3, 2017. Raymond motioned to accept them as written and Wayne seconded; all were in favor.

RSU74 Superintendent Michael Tracy presented to the board and all who were present the budget process for the school system and how it works.

Mike Malesky presented a copy of the MVR to the board members for them to review. The Board members reviewed the MVR and signed it.

The Board members reviewed and signed payroll warrants and A/P warrant in the amount of \$121,140.27

There was a lengthy discussion regarding the current snowplow contract and what the requirements were that were in it. There was some question presented by Becky and Gilbert Taylor regarding the insurance requirements which are listed within the contract. After thorough review the Board of Selectmen made no decisions to change or amend the current contract. There were also some suggestions on how to move forward with the contract in future years. It was also brought to the board's attention that the contract ended in June of 2018. And a new bidding process would need to be started first thing in the spring of 2018.

The Meeting: The November school board meeting was held at CHS. The cheese and crackers - and especially the whoopie pies - were the food highlights.

Minutes: The minutes of the October school board meeting were approved after a grammar error was corrected.

Superintendent Presentation - Building a Budget: Mr. Tracy has been attending selectmen's meetings this fall to communicate with town officials and citizens about the budget process. He showed a PowerPoint presentation that he has shared at these meetings. His primary goal in building a budget is to increase programming for students, and to do so in a manner that does not bring about large increases to taxpayers.

Appointments: Ross Sirois = boys' soccer coach, CCS; John Vartanian = unified boys' basketball coach, CHS; Heath Cowan - CHS softball; Tony Pranses - after school tutor, CHS; Sarah Harriman - after school tutor, CHS; Janet Boothby - advisory dean, CHS; Aaron Baum - advisory dean, CHS; Sarah Harriman - advisory dean, CHS; Stacey Robinson - advisory dean, CHS.

Resignation: Dustin Zamboni - ed tech 2, CHS

Nomination: Paul Thompson = CHS science/math

Reports: Mr. Tracy plans to hold a mid-year data workshop for the board, perhaps prior to the January board meeting. At this session, board members will spend time with each building administrator and receive updates regarding student progress and performance on MEA, NWEA, SAT, AP exams, etc.

Tim Richards told the board that 39 students had departed CHS on Wednesday morning to attend the Boston-area college trip. Students will visit SMCC, Tufts, Stonehill, and Salem State.

Tom Desjardins recently accompanied Erik Carey on a Boston trip with 30+ eighth grade students. He commended the students on their outstanding behavior. He also thanked Doug Cahill for his work during the recent storm and its aftermath while CCS has been a shelter for citizens without power.

Jean Butler said that she plans to give the board an update in January on how the GS SIG money has been utilized. She noted that many of the elementary school kids were disappointed that Halloween was affected by the storm/cancellation.

Lorie Agren said things have gone relatively smoothly at CCS while the school is being used as a shelter. Several people who are lacking power and heat have spent the night at the school.

Scott Hall had nothing to add to his report that he had previously submitted to the board. He said he felt the cancellation notification had gone well, as it seemed that most everyone was contacted who needed to be.

Nicki Richardson said the number of students identified for special services has dropped from 142 to 138. The special educational review is underway and going well.

Chris Roy said that with the fall sports season over, the crunch for drivers isn't as severe, but that the lack of drivers/subs is his biggest concern. He thanked the drivers for their willingness to take on extra duties during the occasions where they have been short handed. He has worked with the 74 AD, Nate Stubbert, and RSU 59 middle school AD Al Veneziano to organize shared transportation when possible. For example, the CCS and MJHS cross country teams traveled together on several occasions. He apologized for any inconvenience caused by the Monday school cancellation.

Board chairman Bob Demchak praised Chris Roy, commending Roy's handling of the storm day situation. Mike Tracy echoed those comments, saying he is grateful for the team he has with Chris and Lorie.

Mr. Tracy also cleared up some confusion regarding the storm days and the governor's declaration of a state of emergency. The fact that a state of emergency was declared does **not** mean that days do not need to be made up. As of now, the October 30 and 31 storm days will have to be made up.

Committees: The Finance Committee met on October 11. The Policy Committee met on October 18. The board's negotiations committee met on October 12, 18, and 24. Several board members attended the MSMA conference on October 26 and 27. They indicated that the conference was a great experience.

Citizens: No one said anything.

Early Graduation Requests: The board approved the early graduation requests of Makayla Wyman and Hayley Taylor.

Youth in Maine Government: The board approved the November 10-12 Youth in Maine Government overnight trip.

Changing Facilities Coordinator to Facilities Manager: The board approved changing Lorie Agren's title from Facilities Coordinator to Facilities Manager.

Four Hour per day custodian at CCS: The board approved hiring a four hour per day part-time custodian at CCS.

Executive Session: The board entered executive session to discuss support staff contract negotiations. When they entered executive session, I went home. The only item remaining on the agenda at this time was Adjournment.

## Wire Bridge Sno-Travelers

The November 11 monthly meeting was called to order at 6:31 pm with 18 members present.

The secretary's report was read and accepted.

The treasurer reported both the checking and savings account balances. All bills are paid up to date. The treasurer's report was accepted as read.

The trail master reported that he had recently applied for a couple of grants. Also, he and Lew P. worked on ITS84 after the wind storm and removed all of the blow downs. There are a couple of small projects in the works, one of which is re-setting the markers in the fields that blew down. The Trail Master's report was accepted as stated.

Old business: The club is still checking into the possibility of purchasing an electric chainsaw for brushing. The purchase of a brush cutter for the side of the groomer is not feasible this year, as we have made other sizable purchases, but we will revisit the discussion this spring.

New business: This fall the club discussed getting a second groomer, but we were denied a capital equipment grant so the purchase fell through. However, the Millinocket club put an '06 groomer up for sale that fell within our price range. This groomer has a new motor and is in great condition. After approval from all club officers, the groomer was purchased. We have also purchased a used drag to use with the groomer. The club can apply for the capital improvement grant again this year, and if approved, we can put it toward the cost of the groomer.

A trail near Tannery Bridge will need to be slightly re-routed due to a new house being built. The homeowner has offered to help cut and de-stump the new trail. Lewis filled in a big hole on the New Portland Hill Trail that is a problem area for the groomer. We also need to fix a trail that keeps washing out. There is going to be a lot cut on the Hancock Pond Trail, but the contractor will help to straighten out the trail for us and possibly re-route a section. We still have enough poles and plank to construct a bridge behind the Bixby property; a work detail may be organized to work on this project.

The club will have our annual holiday party after the next meeting, Saturday, December 9. Members may bring a snack to share if they like. Those who are interested in participating in a Yankee swap may bring a gift (\$10 limit) to trade. Also, we will be collecting non-perishable food items to donate to the local food pantry as well. All are welcome to attend!

The meeting was adjourned at 7:04 pm.

## **Sand and Salt Shed Committee**

---

### *2017 New Portland Salt Shed Committee Findings and Summary November 20, 2017*

During the budget preparations in January 2017 the board of selectman expressed an interest in looking into the possibility of building a sand and salt shed for the Town of New Portland. At the annual New Portland Town Meeting in March, this was again reiterated and community members who were interested in serving on a committee to research this were asked to step forward. The purpose of doing this research was to determine if there would be any savings to the town if the town owned its own sand and salt shed. Currently plowing and sand and salt storage are done as a combined contract. A town owned shed would allow for bidding on separate

contracts, one for plowing and one for sand and salt increasing the likelihood of a more competitive bidding for winter roads. The first meeting of the committee was held on April 20. There was a large group present consisting of selectmen, interested community members as well as local contractors with experience in plowing and general road maintenance.

A wide-ranging discussion took place at the first meeting in which the following points were discussed:

- Current winter road contract as it pertains to salt and sand storage
- Location of salt and sand pile
- Amount of salt and sand the town uses and related costs
- Possible locations for a shed and permitting that might be required
- Pros and cons of the types of buildings currently used in neighboring towns

The committee met monthly throughout the spring and summer with each meeting having a different focus i.e. possible locations, types of buildings, sand and salt amounts, as well as all related cost and contracts. The dates, times and location of each meeting were posted in the *New Portlander* and were open to the public.

As the committee approaches the end of the calendar year, we realize that the securing the funding and site of a town owning a salt storage shed will take more time than originally thought. However, the need for the town to continue to pursue owning its facility remain an important goal, for the following reasons. The current plowing contractor also is the owner of one of the only two sites in the Town of New Portland that is approved for sand and salt storage. It is reasonable to assume that the current contractor may not always wish to bid on the road contract or not always be the lowest bidder. This would result in leaving the town without a place to store sand and salt within the town, causing potential contractors to put in higher bids to cover the cost of hauling salt and sand from a location outside the town. During our discussions the current contractor has indicated he would consider leasing his approved land, the current sand and salt storage site, to the town. He is willing to do this whether or not he is awarded the plowing contract. This allows some measure of assurance for the town regarding sand and salt storage; additionally it allows the committee to do further research on building its own sand and salt shed.

The committee would like the selectmen to consider budgeting for and entering into a multi-year contract with the current winter road contractor for the current sand and salt storage site. This site would be available for use by any winter roads maintenance contractor to use for sand and salt storage for the duration of their contract. Additionally, the committee wishes to continue to study the possibility of the town owning its own sand and salt storage facility.
