- 1. Raymond called the meeting to order at 6:30 pm.
- 2. Wayne motioned for Andrea to be Chairman of the Board of Selectmen. Raymond seconded and all were in favor.
- 3. Andrea motioned to accept the minutes as written, Raymond seconded and all were in favor.

#### 4. Department Heads:

- a. Kip briefed the board on recent calls. He discussed with the board the recent purchase of a new litter for the department. There was training scheduled for Sunday.
- b. Mike Malesky discussed with the board a tentative meeting for a sand/salt shed meeting. After a brief discussion a meeting was scheduled for March 21at 6:30 pm.
- c. Judi briefed the board on possible activities for the recreation committee. The next recreation committee meeting is scheduled for April 5, and she would bring the selectmen up to date on commitments of activities after that meeting.

#### 5. Items by the Town Manager:

The board reviewed and signed payroll and accounts payable warrants. There was a brief discussion regarding town owned properties and the bid process. ## Planning Board Meeting Minutes for Jan.1, 2018

Members Present: Brian Rundlett, Lewis Wills, Kyle Handrahan, Peter Gardner, Jim Heichel; Present: Stacie Rundlett, Brook Gardner, Mike Malesky, Judi Wills Peter called the meeting to order at 6:35 pm.

There was a brief discussion regarding the CMP violation regarding the wireless antennas. Stacie briefed the board on thoughts that the town's attorney had to try to resolve this issue. It was noted that due to Federal Law changes for Wireless Communications, the Planning Board may want to review and revise the Town of New Portland Wireless Communications Ordinance. The board was comfortable with following through with the suggestions from the town's attorney to try and resolve this issue. Jim motioned to go ahead with the attorney's recommendations, Brian seconded and all were in favor.

Mike Malesky updated the board on the Jordan/ Nickinello subdivision and the amendments that were approved at the last Planning Board meeting. There was no action taken as it was all approved at the last planning board meeting.

The Planning Board reviewed setback amendments for the Middlegate Subdivision that were submitted by Larry Warren. The board reviewed all of the data and mapping information that they had before them. After reviewing the information, the board members were all in favor of approving the amendments made to the setbacks of the subdivision.

## RSU 74 / School Board

The March school board meeting was held on March 7 at CHS. The whoopie pies and crackers were a highlight. I did not sample the fruit though the people who did seemed to enjoy it.

Minutes: The minutes of the February board meeting were approved.

Student Presentation: A JMG presentation was postponed.

Kathy Bertini presented information about the STEM program. She was assisted by Julieanne Belanger and Brian Twitchell. During 2017-2018 RSUs 13-59-74 have benefited from an Embrace Grant, which gives the districts funding for STEM. Ms. Bertini spends one third of the year in each district. While in RSU 74, she has worked with students in grades 3, 4, 5, and 8. Students work with every day consumable objects, like straws, and come to learn how an object as seemingly unimpressive as a straw can be used to make major scientific breakthroughs. Students also work with 3D printers. A slideshow was displayed, which showed students who were highly engaged. Mr. Twitchell and Mrs. Belanger spoke to the board about the impressive levels of student engagement.

Grant money has funded Ms. Bertini's position this year, along with other STEM supplies and eight 3D printers. The three districts have been awarded a STEAM grant (the A being for the arts) for 18-19. Kathy Bertini will be presenting on STEM education in Atlanta later this month, and Richard Reichenbach will be making a STEM presentation at Thomas College soon. Several board members expressed enthusiasm and support for the developing STEM/STEAM program in RSU 74.

Superintendent Report: Mr. Tracy congratulated the five people who had been elected/re-elected to the school board for terms starting in July. The five were Tammy Murray, Bob Demchak, Jessi Campbell, Bob Lindblom, and Dwight Barron.

For 2018-2019, RSU 74 seems destined to lose some state funding due to the fact that the district has not entered into a regionalization center. However, in recent days the DOE has suggested that - in future years - if RSU 74 and the districts it is currently collaborating with were to submit some sort of formal plan, detailing the current level of collaboration, perhaps the plan would be approved and funding restored.

Mr. Tracy will be recommending to the board that in 2018-2019 there be a full-time special ed director (with some teaching responsibility). The cost of the full-time director will be offset by a recommended reduction (presumably through attrition) in the special ed department.

Appointments: Tammy Long - Gear Up Tutoring, CHS; Terry Corson - CCS softball; Luke Tewksbury - CCS baseball; Dave Richardson - CHS softball

Committees: The board's finance committee met in March to discuss the 2018-2019 budget.

Citizens: Tanya Carey of Embden spoke, encouraging the board to consider adding a half-time position at CHS to support the increased student involvement in band and chorus. The number of students involved in chorus/band at the elementary and middle levels is quite large, but once those students reach high school, there are few opportunities for those students to continue.

2018-2019 School Calendar: The board approved Mr. Tracy's school calendar proposal. 175 student days/7 workshop days. One of the workshop days will be dropped in exchange for teachers holding parent conferences. A second workshop day will be dropped in exchange for teachers engaging in professional development (early release days for students/teachers stay until 3:30) on six occasions.

To see if the Board will approve to remove all job descriptions from the current policy manual: The board approved.

To see if the Board will approve updating policies (. . . about 20 policies in all). The board approved.

<u>Comprehensive Emergency Management Plan</u> was approved; it will continue to be reviewed and updated as needed.

To see if the Board will accept the Maine DOE Embrace 2 Grants: The board accepted two grants. One expands upon the STEM grant that RSU 74 shares with 13 and 59 this year. The other grant, also with 13 and 59, creates a middle level (grades 7-9) alternative ed program which will be located at Madison Junior High.

2018-2019 Budget Discussion and Actions: Mr. Tracy stated that in order to bring the 2018-2019 budget in at a level that would cause no increase to taxpayers, \$735,223 would need to be cut.

The cutting began on Wednesday night with what Mr. Tracy described as being the "soft" cuts. Eliminated from the 2018--2019 budget: one special ed teacher - \$64,000; CCS assistant principal position - \$60,500; technology equipment - \$23,000; cut to STEM budget - \$10,000; decrease in course reimbursement - \$10,000; half of a seven hour bus driver position - \$12,500; food service - \$5,000; facilities - \$30,000; Co and extracurricular - \$2,000; evaluation stipend - \$5,000.

These cuts reduced the budget by \$217,000. The board was not content to stop there and leave a more than \$500,000 increase to taxpayers. The admin team were encouraged to produce some more reductions. It is expected the the superintendent will recommend some "hard" cuts at the March 14 budget meeting.

New business: Groomer maintenance and putting the groomers away for the summer will take place. The club will be hiring someone to come take care of the new groomer for a reasonable fee, and the Tucker will be taken care of by club members. Anyone wishing to assist, please contact Lewis Wills.

## **Citizens Corner**

My dear fellow New Portlanders: March 18, 2018 I have an apology to make to you all. I attended our town meeting on March 3. There were about 50 townspeople there in a town of around 700. In an attempt to make things fairer, I have inadvertently and unintentionally made things worse for some of you. There were two warrants that were involved - #30 and #32. One stated there will be a 7% interest rate charged on unpaid taxes and the other stated the town only has to pay 3% on taxes that have to be returned due to an abatement. Why should the people who owe taxes be charged a higher percentage on their debt than the town pays on their debt? When warrant #30 came up for a vote, I brought this discrepancy up and asked that the interest on unpaid taxes be reduced to the 3% that the town has to pay. It was brought up that it would be easier to raise the tax rate on the abatements since there are less of those occurring than nonpayment of taxes. This would put less of a financial burden on the town. My motion was voted down.

I thought it was over and the suggested rate of 7% would then pass. But that was not the case. A voice from the back of the room then made a motion to raise the rate to 8% since that is currently the max that can be charged. I was taken by surprise and couldn't figure out why this motion was made. Later I found out that this motion was made by our newest selectman. There was no good reason for her to make this motion except that she could since towns are allowed to charge the max allowable amount. It is only causing increased hardship to the tax payers. People don't pay their taxes for many reasons. Some reasons may be that they have a fixed income, they have experienced a sudden catastrophic event such as an illness or job loss, or they just pay when they are forced to pay. It is those hardworking people who have a sudden catastrophe in their lives and those on a fixed income who have it the worst. Charging them the max interest only adds to their debt which they are more and more unable to pay. They get buried in a larger ever growing debt. It puts undue stress on those who are already in a stressful situation. I was also told that 8% is the rate that has been charged for years. That doesn't mean it is the best thing to do just because we can. Why not give our townspeople a break? Wasn't this country's revolution caused by increased taxes? We are taxed on everything anymore. I don't know about you but I work hard for my money and I would like to enjoy the fruits of my labor. I also understand that we have to maintain the town so we can enjoy that but how much difference was a 1% increase going to be?

I don't know how to fix this until it comes up for a vote next year. I am apologizing for being the catalyst that caused events to happen that raised the taxation rate to 8%. Please forgive me. My other plea is that we all become more knowledgeable with what goes on in this town. It affects us all. I have been too uninvolved. I don't understand how town finances work and I need to learn so I can make better recommendations at the next town meeting. Please join me. It is our town and we can affect change. I felt at that meeting that no one wanted to listen and everyone just voted they way it was recommended. It was very evident at the discussion about the salt shed and a lack of discussion about changing the street lights to LED to save money.
