Selectmen's meeting minutes for December 18, 2017

Selectmen Present: Wayne Rundlett, Raymond Poulin, Michael Senecal (absent); Present: Stacie Rundlett, Brian Rundlett Raymond called the meeting to order at 6:30 pm.

The Board of Selectmen reviewed the minutes from December 13, 2017. Wayne motioned to accept them as written and Raymond seconded, all were in favor.

Stacie shared with the board of selectmen a proposed spreadsheet for 2018 assessing budget and fire department budget. The board and Stacie discussed the data that she had for them. The board decided to make no decisions until they could meet as a complete board.

Stacie discussed with the board that the town's attorney suggested they work with CMP on the violation due to the wording of the town's ordinance. Stacie suggested that they have the attorneys try to work out those details.

Stacie reviewed with the board the liability issues with leasing a site for a sand/salt shed. If a parcel of land is grandfathered with the DEP laws once it changes hands the parcel loses the grandfather status with DEP. They reviewed all of the information they had on hand. At this time the board felt there were a lot of things to take into consideration, and it would be discussed much more in detail at the scheduled January 10 meeting.

Selectmen's Meeting minutes January 2, 2018

Selectmen Present: Mike Senecal (chairperson) Raymond Poulin, Wayne Rundlett; Present: Stacie Rundlett, Mike Malesky, Brian Rundlett, Brenda Joy Stevens, Dallas Landry, Ron Lindner-Demers, John Demers-Lindner Mike Senecal called the meeting to order at 6:32 pm. Raymond motioned to accept the minutes as written; Wayne seconded, and all were in favor.

Kip updated the board on calls. He briefed the board on maintenance repairs being done on light fixtures in the bay of the fire station. There was a discussion regarding the recent problems with the heating system at the fire station. Bob's Cash Fuel looked into the matter and had to return again to determine why the building was not heating properly. Kip and Stacie will keep the board updated as they know more.

Mike Malesky updated the board that he had been working on reports for the state and made sure they were sent on time.

Brian updated the board on Planning Board meetings with subdivision amendments.

Dallas gave his apologies for not getting the Planning Board minutes into the January *New Portlander* as an oversight. Stacie recognized that Dallas did an exceptional job making sure that the *New Portlander* was printed and delivered to the town in time for them to get out before the New Year.

There was a brief discussion regarding the conditions of the roads. Mike Malesky inquired about the Sand/Salt Shed meeting time and place.

Stacie presented the warrants to the board. The board reviewed and signed all payroll and the accounts payable warrant from year end 2017. Stacie updated the board on the scheduled appointment with the town auditor for lanuary 18.

Stacie presented updated budget spreadsheets for the board to review. There was a brief discussion regarding the breakdown of a few department lines. She will present completed spreadsheets to the board by the January 15 meeting. This is when they will need to be finalized from the board of selectmen. A budget committee will be scheduled as soon as the board finalizes their budget requests. There was a brief discussion regarding possible dates.

The board discussed briefly sand/salt shed business. Stacie reminded the board that they will also need to consider what figure they want in the budget line for the winter roads, as this is the last season for the current contractor, Gilbert Taylor.

Sand and Salt Shed Committee

The Salt Shed Committee met on January 10 at the New Portland Town Office to discuss the feasibility of leasing the property currently used for the town's sand and salt storage.

The selectmen and town manager, after researching the leasing proposal posed by the committee at the November meeting, discovered multiple challenges to leasing. In addition to the cost of such a lease the town would have to assume all the liability on the property as well as create physical barriers to secure the area. Additionally, it is unlikely that the grandfathering of that property for the purposes of sand and salt storage from the owner to the town as lessees would be allowed by the DEP.

The second option the committee had discussed throughout its meetings in 2017 was for the town to purchase land and build its own sand and salt storage facility for the following reason. The current plowing contractor also is the owner of one of the only two sites in the Town of New Portland that is approved for sand and salt storage. It is reasonable to assume that the current contractor may not always wish to bid on the road contract or not always be the lowest bidder. This would result in leaving the town without a place to store sand and salt within the town, causing potential contractors to put in higher bids to cover the cost of hauling salt and sand from a location outside the town.

The selectmen therefore decided at their January 15 meeting to continue looking for a forward thinking solution to sand and salt storage for the town. They are proposing an article for the 2018 town meeting warrant and an amount of money to pursue purchasing land and constructing a building for sand and salt storage.

RSU 74 / School Board

The January 10 school board meeting was held at Garrett Schenck. It was a surprisingly quick meeting. Another highlight was the food, particularly the chili that Brenda Mullin prepared.

Minutes: The minutes of the December 6board meeting were approved.

Student Presentation: Lisa Savage, Brittany Dunham and three GS students discussed Power Reading. A second grade student, Karley Gordon, demonstrated to the board how students sound out words and syllables. Two other students, Hickory Smith and Seth Hanson talked to the board about the activities they do in reading class. They work with letters, vocabulary words, prefixes and suffixes, have dictionary scavenger hunts, and play Two Lies, One Truth with vocabulary words. They quickly played the Two Lies, One Truth game with the board.

Superintendent Report: The financial picture remains rather ominous. At current spending projections, RSU 74 will finish the year at 0.7% on the good side. A spending freeze has been implemented.

On the subject of statewide school consolidation/ regionalization, there have been many rumors regarding penalties that will be imposed on schools who do not find a partner. At one point, the belief was that schools could be hit with a penalty of as much as \$120 per student. The current rumor is that the penalty will be roughly \$30 per student, which amounts to \$20,000 for RSU 74. The state has still not said anything definitive, so this number could be different by the next board meeting.

The ad hoc AOS committee has been invited to a meeting in Madison on January 25 at 6:00 pm.

Resignation: Sarah Harriman, CHS English teacher - effective February 24

Nomination: Issac LaCasse - special ed teacher, CCS Admin Reports: Tim told the board that on January 10, 37 students participated in a Skype session with Senator Angus King. Also, the Cole Land Transportation Museum is donating RSU 74 \$10,000 worth of musical instruments. 50 CHS students will visit the Cole Land Transportation Museum in May. The Cole Museum also donated 50 Kindle Fires to RSU 74, and they have given a grant to fund Reading Recovery Training, according to lean.

Tom commended the Carrabec Community School boys' basketball team for their effort and attitude in a recent basketball game. He thanked Lorie for her efforts during the first week back from vacation when CCS had major heat issues.

Lorie said that the pellet boiler is down and is in need of repair. The Carrabec High School roof has been shoveled, and the GS roof will be soon. She thanked Chris Roy for his help when CCS was having heat issues.

RSU 74 has a contract with Siemens, but it will be under review.

Committees: The negotiations committee met December 14 and January 10. The policy committee met in December. Mr. Tracy and board chairman Bob Demchak attended a recent SCTC meeting.

Citizens: Alan Walker, a resident and bus driver, encouraged the board to by diesel buses in the future, as he believes diesel buses are a better investment than gas buses.

Purchase of a third bus: RSU 74 is eligible to purchase a third bus. (Two were purchased earlier in 2017-2018.) The board approved the purchase.

To see if the board will insert the proposed language into section "2 secondary" in school policy JJIC, effective beginning of AY 2018-2019. The board approved.

To see if the board will replace school policy IJNDC and add IJNDB, and add IJNDB-R in place of IJNDC. The board approved.

To see if the board will delete school policy AFC/GCN Evaluations. The board deleted.

<u>To see if the board will update school policy DJ - Add legal language to DJ.</u> The board added.

To see if the board will discuss declining enrollment in winter sports. Nate Stubbert spoke to the board about CCS sports, primarily the 7th grade boys' basketball team. The team has struggled this season, losing often by more than 40 points. Nate feels that the team, which plays in the Central Maine League, would find more success in a different league, possibly the Augusta-area Capital Area League. He hopes to make a recommendation to the board in February.

Board member Tammy Murray spoke about middle school basketball and declining sports enrollment in high school. She believes that the athletes become frustrated in middle school because they lose so frequently and by such large margins. That frustration then leads some to give up on school sports by the time they reach high school. She would like to see CCS offer sports to only seventh and eighth graders, while sixth graders could play sports for town rec teams.

Executive Session: The board entered executive session to discuss support staff contract negotiations.

The executive session was the last agenda item other than adjournment. The regular portion of the meeting was concluded by 7:05 pm, which was much earlier than recent meetings.
