#### Minutes for Selectmen's Meeting December 16, 2019

Present: Raymond Poulin, Wayne Rundlett, Andrea Reichert; Present: Stacie Rundlett, Brian Rundlett, Kristen Mitchell, Michael Wales, Kip Poulin

- 1. Call the meeting to order: Andrea called the meeting to order at 6:30 pm.
- 2. Review minutes from previous meeting: Raymond motioned to accept the minutes as written, Wayne seconded and all were in favor.
- 3. Old Business:
  - a. Wayne briefly discussed with the board that Lloyd Dalton notified Stacie that during this upcoming school year some high school students would assist in cleaning up the graveyard on Atwood Hill Road that had been in a selectmen's meeting discussion a short time ago.
- 4. Department Heads: Kip went over his proposed 2020 budget with the board members. There is an increase from years past as the department needs to purchase turn out gear to be compliant with regulations.
- 5. Items by the Public: There were none.
- 6. Items by the Town Manager:
  - a. The board reviewed and signed payroll and A/P warrants.
  - b. The board and Stacie reviewed a draft policy for residents to access sand salt mixture. The board was in agreement to this draft, and Stacie will post it accordingly. The board agreed that two five-gallon pails of sand per storm for residential use only. There was some discussion regarding liability and the board asked Stacie to contact MMA to confirm details on how to proceed with this part of the project. There was also a brief discussion regarding the lumber that was left on site from the project. This lumber was proposed to be used to build a small shed to store the sand for the public to use. Brian volunteered to get tarps to put on the lumber as it currently is exposed to the elements.
  - c. The board and Stacie reviewed a draft policy for internal control of financial policies and procedures. The board was in agreement to this draft. The board decided to continue more budget talks at their next scheduled meeting and tentatively schedule the budget committee meeting for Saturday, January 25 at 9:00 am.
  - d. Andrea motioned to enter into executive session pursuant to 1 M.R.S.A. §405(6)(A) for personnel matters at 7:17 pm. Wayne seconded and all were in favor. At 7:41 pm the board entered back into the public meeting. There were no decisions made in executive session.
- 7. Items by the Board of Selectmen: There were no items by the board.
  - Meeting adjourned at 7:42p.m.

## RSU 74 / School Board

#### What is Cost of Doing Business?

Over that last few years that I have served as superintendent in RSU #74 I have discovered a phrase that often gets uttered during the budget season. That phrase is "the cost of doing business."

As I have been thinking recently about RSU #74 and our annual budget season, I am determined to work to publically illustrate this year just what those "costs of doing business" really are.

Costs such as facilities and utilities, curriculum, assessments, supplies, transportation and human capital all have their places in the operational budget of the school system. But beyond that, I have been thinking about what we "get" from our investment in the school system?

As I have been thinking about this, I realized that just last month, for example, we have not only educated our children (the basic requirement of the school system), we have provided food, gifts and personal toiletries to families along with helping to raise money for fuel assistance, administered medications, checked for scoliosis, vision screening and dental health. The school system is not only the educational center for the public, it has become the epicenter for the public providing services beyond educational needs...

**Did you know...** RSU #74 has received over \$300,000 worth of services for STEAM education, and Alternative Education over the last few years? ... Therefore, we know we have to help meet basic human needs before we can meet educational needs; this means the school system has become so much more.

In addition to the basic human needs that the school system fulfils, major cost drivers in the budget such as school facilities and special education continue to rise. Like home ownership, there is a cost to owning our schools and maintaining them.

So, this year, as we begin participating in another budget season, I will make it my aim to discuss all of the costs of doing business!

All of these goals above reflect the direction in the approved strategic plan, governed by the RSU #74 school board.

**RSU #74 continues to work to save money:** Saving money comes in a variety of ways. It also comes from bringing a variety of money INTO the school district.

Over the last three years we have received monies from grants for our STEAM education programs as well as Alternative Education.

Our STEAM education has fostered many, many new opportunities for children (and teachers) by working on innovative learning that will propel them into the 21st century workplace. Additionally, we have improved programing for students who have needed alternative or

multiple pathways from high school down to grade six. We are pleased to continue to work with Madison and Bingham on these efforts. Lastly, we have been able to cut a bus run and reroute travel time to have a very limited effect on students, while saving money at the same time.

I will continue to make the commitment to find the best educational programs, efficiently.

## District Goals: Just a reminder of the things we are working on this year...

Goal 1: Data Driven Instruction - This means that we are taking a closer look at our assessments to determine student needs, and allow this information to inform our instruction!

Goal 2: Community Involvement - This means we are working to make our schools more and more inviting to the public and creating more opportunity to be in the public to serve. RSU # 74 continues to work to save money.

Goal 3: Trauma-Informed Schools - This means that our school district is making a concerted effort to become more informed about child and family crisis, and how to serve them better.

#### **Board Meeting for January**

He thanked his administrators for their work in presenting at the data meeting that was held prior to the board meeting. The superintendent informed the board that teacher contract negotiations will begin soon. A video was played that can be found on the RSU 74 Facebook page.

Admin Reports: Jean Butler welcomed the board to Garret Schenck. She said the place settings at the board table were made by Mrs. Hebert's kindergarten students. Tom Desjardins updated the board on the wrestling program. About 40 kids attend each practice. The wrestlers will compete in five tournaments; the first tournament is only two weeks away. In March, the Cobra wrestlers will host a tournament at Carrabec High School.

Committees: The Academic Committee met on December 18. The committee discussed how NWEA and SAT data is used to inform instruction. Appointments: Andrew Ferrari - CHS jv boys' basketball; Jessi Campbell - secretary, CHS

Resignation: Anthony Pranses - CHS math

Election: Bruce Dostie - CHS math

Citizens: Brenda Mullin spoke. She wanted the board to be aware that prior to the meeting, she handed Bob Demchak some letters signed by many RSU 74 staff members. The letters expressed support for the work that Mr. Tracy has done during his time as superintendent.

Van Issue: The board voted to spend up to \$34,000 for a minivan that has cameras.

Budget Timeline: The budget process will unfold during March, starting with the March 4 board meeting. Budget meetings are scheduled for March 11 and 18.
