NOTICE OF TAX SALE

The Board of Selectmen of New Portland is accepting bids for the purchase of the municipality's interest in New Portland's tax-acquired property. The Selectmen have decided that there will be a minimum bid for this property of an amount being \$1,500.00. Each bid must be in writing and in a sealed envelope marked **"Tax sale bid"** on the outside. The Board of Selectmen must receive all bids no later than **5:00 o'clock pm on April 3, 2018**. Late bids will not be opened or considered.

Each bid must also include the bidder's name, mailing address and phone number and must be accompanied by a deposit in the form of a certified check or money order, in an amount equal to or greater than 10% of the bid price. Each successful bidder's deposit will be credited to the total purchase price for that parcel. Deposits will be returned to the unsuccessful bidders. Any bid, which does not contain the proper deposit, will be rejected. Bids will be opened, reviewed and awarded by the Selectmen at the Selectmen's Meeting on **April 3, 2018 at 6:30 pm**. The Board of Selectmen reserves the right to reject any and all bids. Each successful bidder shall have 30 days from the date of the bid acceptance in which to complete the purchase. The property will be conveyed by a quitclaim deed without covenants. In the event that a successful bidder fails, for any reason, to complete the purchase in the time stated, the bid acceptance is void and the bidder's deposit shall be forfeited to the Town. The Board of Selectmen may thereafter negotiate a sale of the property with any or all-unsuccessful bidders.

Selectmen's Meeting Minutes for February 6, 2018

Selectmen Present: Mike Senecal (Chairperson) Raymond Poulin, Wayne Rundlett; Present: Stacie Rundlett, Brian Rundlett, Judi Wills, Mike Malesky, Kip Poulin, Ron Lindner-Demers, John Demers-Lindner

- 1. Mike Senecal called the meeting to order at 6:30 pm.
- 2. Wayne motioned to accept the minutes as written, Raymond seconded and all were in favor.
- 3. Department Heads: Mike Malesky updated the board on his recovery from medical leave. Kip Poulin, updated the board on truck repairs and upcoming training. He spoke briefly of the dangerous building the fire department burned, and all that was left was small debris for the town to have removed. Stacie reviewed with the board a letter of violation that was being submitted to CMP.
- 4. The Board of Selectmen and Stacie reviewed the annual town meeting warrant. They approved it and signed it. They also reviewed and signed the payroll and accounts payable warrants. The board discussed with Stacie that the one (1) property on which they

had foreclosed was land only and would go out to bid. They set a date of April 3 to accept bids; they would open those sealed bids at their meeting that night. Mike Senecal motioned to table the property that just had the dangerous building burned until April 3 to determine the next course of action. The board also decided that the last property which was foreclosed has until April 3 to sign a Land Purchase Agreement, which is required by law. Stacie would reach out to the land owner again. There was a brief discussion regarding the Town Warrant and article 11, which is asking for the towns approval to borrow funds for a sand/salt shed facility. Stacie provided the board members with an updated budget worksheet including amounts to be appropriated through taxation.

5. Raymond updated the board members and the public in attendance that at this time the AOS, with RSU #74 is on hold.

Meeting adjourned at 6:59 pm.

RSU 74 / School Board

The February school board meeting was held on Thursday, February 15 at Solon Elementary School It had been scheduled for February 7 but was postponed due to weather. The food was a major highlight. Sandwiches had been prepared, and the six that I ate were outstanding.

Minutes: The minutes of the January board meeting were amended, but approved.

Student Presentation: Sixteen students from grades k-5 displayed their basketball skills. Terry Corson organizes Kitty Kats basketball each year. He started the program in the 1980s, when Solon was a k-8 school. Only the older students (grades 6-8) could participate in school basketball, so Kitty Kats gave the younger students a way to be involved. Students who participate in Kitty Kats learn basketball, but they also learn about sportsmanship and teamwork.

Superintendent Report: The 2018-19 budget outlook is challenging. The current projection is that RSU 74 will be receiving about \$200,000 less in state funding. Equally ominous, the local towns will be required to raise (approximately) an additional \$200,000, resulting in a gap of \$400,000. The board's Finance Committee will be meeting in order to come up with recommendations. The plan is to tackle the 2018-19 budget in three March meetings - the regular March 7 board meeting and budget meetings on March 14 and 21.

RSU 13, 59, and 74 received a STEM grant in 2017-18 and have shared Kathy Bertini. The three RSUs will continue to receive grant money in 2018-19, as a STEAM (the A is for Arts) grant has been awarded. The grant money will pay for expanded STEM labs, 3D printers, and additional math coaching.

A middle school alternative ed grant has been awarded to RSUs 13-59-74. The program will be located at Madison Jr. High. Grant money will fund a teacher and an ed tech for the program.

Appointment: Mat Brown - CCS track coach

Resignations, effective at the end of 2017-18: Stephanie Campbell, CHS Art; Peter Manning, CHS math/ science

Admin Reports: 1.) Tom Desjardins congratulated the CCS boys' and girls' basketball teams, who both won the recent Pine Cone League tournament. 2.) Jean encouraged the board members to attend the Kitty Kats basketball performance on February 28 at Solon. She thanked North Star Orchard for donating a bag of apples for every student in grades k-5. 3.) Nikki Richardson said the recent special ed audit done by DOE had been a great experience. She said there were five minor tweaks and a slight policy update needed, but in general, the audit went very well and was a great professional development opportunity. Mr. Tracy expressed gratitude to Nikki and to her staff, commending them on how well they handle paperwork and deadlines. 4.) Lorie Agren said things are running smoothly right now. Janitorial staff will have some mid-year training. The training is free, and Mr. Tracy said he hopes there will be more trainings in the coming year(s). 5.) Nate Stubbert congratulated the CCS basketball teams for their success. He also commended both CHS basketball teams for reaching post-season play. Banners commemorating past athletic successes are now hanging in the CHS gym.

Committees: The board's Negotiations Committee met on January 10 and January 24. The board's negotiating team reached an agreement with the support staff negotiating team on a new three-year contract for 2018-2021. Later in the agenda, the board would vote on whether to approve the proposed contract.

The board's Finance Committee met onJanuary 14, and they examined projected revenues for budget year 2018-19.

The Buildings and Grounds Committee met in January to discuss terminating a contract with Siemens. This would appear later in the agenda.

The Academic Committee met with the three building principals on Feb 13.

Citizens: Rob Peabody of Solon spoke; he about an agenda item. When combining sports teams, he stated he hoped decisions would be based numbers of athletes participating. He also said he hoped citizens would have a voice in decisions to combine sports teams with other schools.

<u>To see if the Board will approve the second reading</u> of replacing school policy IJNDC and adding IJNDB, and adding IJNDB-R in place of IJNDC. The board approved.

To see if the Board wishes to take action regarding giving the Athletic Director the flexibility to collaborate to combine teams as needed based on numbers in order to continue to provide opportunities for students and keep the integrity of competitive programs at the High School level. Discussion of this item took about fifty minutes. Mike Tracy reiterated that the purpose of combining a CHS sports team with another school would be to provide opportunities for students. If it looked as if the numbers would be too low to field a team, then combining would be considered. Nate Stubbert addressed the sports that posed an immediate concern due to lack of numbers: boys' soccer, cross country, and golf. RSU 13 has been approached but seems to have no interest in collaborating in sports. The board voted to approve this agenda item.

<u>Terminating the Contract with Siemens</u> RSU 74 is currently in a contract with Siemens. When dealing with recent heating issues, Siemens has not been particularly helpful. The board followed the recommendation of the superintendent, and they voted to terminate the contract with Siemens.

<u>To see if the Board will discuss next year's Special Ed</u> <u>Director position</u> During 17-18, RSU 74 has had a special ed director one day a week. Mr. Tracy hopes to have a full-time director next year Nikki Richardson spoke, and she advocated having a full-time director next year. She said the special ed staff is working hard, but in the current situation, too much is being asked of the special ed teachers. This topic will be revisited at the March meeting, and Mr. Tracy will propose two or three different scenarios for the board to consider.

<u>Executive Sessions</u> There were three executive sessions. After one of the executive sessions, the board voted to ratify the proposed support staff contract. As the association ratified the contract earlier in the week, the 2018-2021 support staff contract is now official.

MATE Housing Ministry

Headquartered at the Fairbanks Union Presbyterian Church

WHO? Volunteer Mission teams from all over the northeast come to western Maine to share their talents and caring with area homeowners, who without assistance with labor and/or materials, would be unable to make needed repairs and maintenance to their homes. Many of the volunteers take vacation time to be here.

WHAT? Painting, roof repairs, porches, steps, ramps and simple interior and exterior repair are likely prospects for the teams. <u>Wherever possible, we ask homeowners and families to participate in the work and its cost</u>. At times the mission can help with materials through grants and donations.

WHERE? Currently we are serving mostly Franklin County: Farmington area, Chesterville, Jay, N. Jay, Livermore Falls, Wilton, New Sharon, Temple, Strong, New Vineyard. Somerset County: New Portland, Lexington, Highland Plantation & Embden. Volunteer work groups stay in North New Portland and Farmington, and we like to keep the work within 30 minutes of these towns. The Salem Economic Ministry, East Parish Housing Ministry [Starks] and RCAM in Leeds also have similar programs that cover the other towns not listed above, but we are also looking forward to broadening our own scope outward.

WHEN? Volunteer Mission teams arrive during the months of June, July and August. The date and time the team will be at your home will be coordinated with you if your application is accepted.

WHY? The MATE Housing Ministry was created to help people in need stay in their home by doing needed repairs they could not otherwise afford to do. The volunteer Mission teams seek to do Christian service. They are called out of their everyday lives to serve in our community. They come to work on housing and would be pleased to work along with you. Their experience is made better by the time you share with them.

HOW? If you own (or are buying) your home, all you have to do is to fill out this application and return it. Each application received will be considered, and you will be contacted for further information if necessary. We will call you to set up an assessment appointment, and we will notify you, whether or not we are able to do the work requested.

MATE-NPHM determines what applications are accepted based on the skill levels of the volunteer teams and the extent and complexity of the work requested. We do our best to prioritize the requests as to those most in need of assistance. We cannot guarantee that we can do everything requested, and it must be kept in mind that the work will be done by volunteers with varying skill levels. Whatever we do is done with the safety of the volunteers as our highest priority, and in completing a job to our mutual [client & NPHM] satisfaction.

Mortgages held by other than a financial institution: In cases where the mortgage is held by other than a financial institution, MATE-NPHM will require them to also sign off on any repairs made.

Anyone wanting to ride to the breakfast by snowmobile is welcome to meet at the Chick Road crossing at 7:00 am. The meeting was adjourned at 7:06 pm.
