## Selectmen's Meeting Minutes for April 2, 2019

Selectmen Present: Raymond Poulin, Andrea Reichert, Wayne Rundlett; Present: Stacie Rundlett, Kip Poulin, Brian Rundlett, Marilyn Gorman, Judi Wills, Mike Malesky, Kristen Mitchell

- 1. Andrea called the meeting to order at 6:31pm.
- 2. The board reviewed the minutes from previous meeting. Raymond motioned to accept the minutes as written. Wayne seconded and all were in favor.
- 3. Department Heads:
  - a. The Town Clerk reviewed with the Board of Selectmen a list of the unlicensed dogs. Kristen stressed the importance of the ACO getting certified letters out to those who have not licensed their dogs, and how it could possibly be a liability for the town if we don't follow through. Kristen presented appointment papers to the board to review and sign. Wayne motioned to appoint Kip Poulin as Fire Chief for one year. Andrea seconded and all were in favor. Wayne motioned to appoint Stacie Rundlett as Code Enforcement Officer for one year, Andrea seconded and all were in favor. Wayne motioned Leo Mayo as Local Plumbing Inspector for one year, Andrea seconded and all were in favor.

- b. Mike Malesky reviewed with the Board of Selectmen a Tree Growth penalty in the amount of \$177.03. Stacie provided all of the commitment paperwork for the Board of Selectmen to review and sign. The paperwork was signed, and the penalty will be sent out tomorrow. Mike also reviewed with the board six places that have had buildings collapse from snow load this winter. Mike also reviewed with the board the decrease in Tree Growth values determined by the State of Maine.
- c. Kip Poulin updated the board on the possible sale of some old equipment on an auction site. The fireman's association had a map made of all of the coverage area that the fire department covers for fire protection. They will also be having some book made up similar to a gazette. The projector will be installed soon. Kip briefed the board on some repairs on the trucks.

#### 4. Items by the Town Manager:

The board reviewed and signed payroll and A/P warrants. The board reviewed and signed documents for the Maine Municipal Bond Bank loan. The Board reviewed and voted to accept all seven items on the proposed vote document supplied by the town's attorney with regard to the Sand/ Salt Shed loan. The document will be on file with the Sand/Salt Shed documents. Stacie discussed with the board that funds were getting lower and taxes for 2019 wouldn't be committed until July. The board discussed looking into rates for a Tax Anticipation Note loan. After discussing the matter more thoroughly the board decided to have Stacie look into getting a TAN for not to exceed more than \$350,000. Stacie would get interest rates from a few banks that the town typically does business with. The Board of Selectmen reviewed and signed the Special Town Meeting Warrant, to be held on Monday, April 15. Stacie will post all the documents in the necessary places. Stacie updated the board that she will be out of the office from April 11 through April 18.

- 5. Items by the Public: There were no items by the Public
- 6. Items by the Board of Selectmen:

Raymond presented to the board a letter to submit to the RSU 74 School District that New Portland's Board of Selectmen did not support the current proposed budget. All reviewed and signed the letter, and Raymond was going to deliver the letter to Bobbi-Sue Harrington, a New Portland School Board member. The Board of Selectmen reviewed a financial document from the library that was left in the Town Office drop box. There was no date on the document

and Stacie and Kristen had no idea how long that document had been in the drop box.

Meeting adjourned at 7:20 pm.

- 1. Andrea called the meeting to order at 6:31 pm.
- 2. Raymond motioned to nominate Andrea as Chairperson, Wayne seconded and all were in favor.
- 3. The board reviewed the minutes from previous meeting. Raymond motioned to accept the minutes as written. Wayne seconded and all were in favor.
- 4. Mr. Tracy addressed all in attendance and handed out information regarding the 2019-2020 District's proposed budget. There was a lengthy discussion regarding the process and how the figures were obtained. Several questions were asked and answered.
- 5. The Highland Assessor's and the New Portland Board of Selectmen discussed with the Fire Chief fire coverage options for New Portland to cover Highland. There was a lengthy discussion regarding this matter and the proposed options. Both towns will need to have public hearings and a special town meeting regarding the matter. There were two options agreed upon.

#### 6. Items by the Town Manager:

The board reviewed and signed payroll and A/P warrants. The Board of Selectmen reviewed and signed the Treasurer's Report. Stacie had the board members sign posted road signs for Summer Roads. The Board of Selectmen discussed the changes they would like on the draft advertisement for the sand/salt shed foundation work. Stacie was asked to contact the engineer to see if he could attend a prebid meeting before the bids needed to be in by for said foundation work.

#### 7. Items by the Board of Selectmen:

Andrea opened the bids for the community room paint project. 1.) Handy Andy-\$850, 2.) Moosebrook Painting-\$1,000, 3.) Vandry Paining-\$2,000 or \$2,500. After a brief discussion all the board members were in agreement that Handy Andy was the bid that they

would go with. The board members decided not to discuss the Highland fire coverage matter anymore since there would be a public hearing as well as a special town meeting. Kip updated the board members on the sale of some old fire equipment. All of the board members were in agreement to have the public hearing and Special Town Meeting at the April 15 selectmen's meeting.

Meeting adjourned at 7:41 pm.

## RSU 74 / School Board

The April school board meeting was held at Carrabec Community School.

Minutes: The minutes of the March 6 regular board meeting and the March 13 special board meeting were approved.

JMG Presentation:

CHS JMG advisor Kim Cole and three students Ashley Cates, Maddie Hughes and Gabbie Hughes addressed the board regarding JMG's accomplishments this year. Community involvement and career development are among the major goals of JMG, and based on the information the three students shared, JMG has had a successful year. Students have worked as Santa's Helpers to give presents to children in need, and they have raised money for the Maine Children's Home. They have held a blood drive, and students volunteered at Maplecrest. At the recent Career Development Conference, Carrabec JMG students were honored. Maddie Hughes and Lillian Johnson won scholarships. Ricky Gordon and Lillian Johnson each took home a first place trophy.

Superintendent Report: 1.) Prior to the board meeting, the board's policy subcommittee met. They reviewed policies dealing with medicine and purchasing. Policy revisions will be discussed at the May board meeting. 2.) RSU 74 has received communication from SAD 58 expressing an interest in discussing collaboration and shared services. 3.) RSU 74 will host a rural attendance summit on April 11 in Brewer. 4.) The WMEC professional development day at UMF on March 22 earned positive feedback from participants.

Resignation: Patricia Reid - CHS English, effective at the end of the school year.

Admin Reports: 1.) Tom Desjardins invited board members to watch the CCS wrestlers compete at

the April 6 wrestling event at Madison High School.

2.) Jean Butler highlighted upcoming community events. On April 8, there will be a Planetarium at GS. The Community Literacy Team will host an Adventure Night at CCS on April 11. Solon will host a Family Wellness Night on May 30. Jean also noted the Bikes for Books program, and thanked the local Masons for their support. 3.) Julie Richard gave the board spring sports schedules for CCS and CHS. She gave participation numbers as well. At CHS there are 21 playing softball, five playing baseball for the Bridgeway Bandits, 15 on the track team, six playing boys' tennis, and 11 on the girls' tennis team. At CCS are 18 signed up for baseball, and 16 are signed up for softball.

Citizens: Several people spoke with thoughts about the proposed school budget, and one spoke about sports concerns. As the *Morning Sentinel* addressed this earlier in the week, I will not recap all of the comments.

The Budget: Mr. Tracy stated that after visiting each of the towns, he came away with the sense that the citizens are supportive of the schools but find taxes to be a problem. He feels that going forward, three things are needed: 1. External collaboration - sharing with other districts - must be explored. 2. Internal consolidation - which could include building closures - has to be considered. 3. A quality educational program must be maintained. The following changes were made to the proposed budget: 1. the budget had money for a literacy coach position. this was cut, for a savings of \$50,000. 2. it was decided that we could go an extra year without a wi-fi upgrade. this saved \$10,000. 3. \$20,000 was cut from the special ed budget. 4. \$23,000 was cut from teacher salaries. in the event that the legislature passes (and the governor signs) legislation to make the minimum teacher salary \$40,000, it appears the state will pick up the cost initially. 5. \$100,000 of carryover money will be applied to reduce the level of local increase. With the above changes, the budget increase will be \$293,722. The board approved the changes 9-4.

To see if the board will reassume authority to approve all athletic mergers with other school districts. There was much discussion. The board voted to take back the power to approve sports mergers. The vote was 8-5.

To see if the Board will approve RSU 74 joining the Western Maine Regional Service Center and authorize the superintendent to sign the interlocal agreement. The board approved and authorized. Previously, the district had not joined because once a district joined it could never withdraw. The terms have changed, so currently RSU

74 will pay \$800 to join but will be free to opt out on a yearly basis.

Signing of the Warrants: (I did not stay to watch, but I am quite confident that the board members signed the budget warrants. After the warrants were signed, the only agenda item remaining was adjournment.)
