RSU 74 / School Board

The April School Board Meeting was held at Carrabec Community School. A handful of board members were in attendance, and the rest attended through computer application Zoom.

Adjustment to the Agenda: The last item on the meeting agenda was scheduled to be a discussion of the potential closure of Garrett Schenck. This discussion was postponed. It will not be revisited until board meetings return to the "normal" format.

Minutes: The minutes of the March 4 board meeting, the March 11 budget meeting, and March 16 special board meeting were approved.

Superintendent Report: 1.) Mr. Tracy thanked the families and staff of RSU 74 for the patience and kindness that they have displayed, and the hard work that they are doing. 2.) He was happy to report that JMG has received a grant to donate to families in need. More than 200 food boxes will be delivered to families in need prior to April Vacation. 3.) The superintendent summarized LD 2167. Among the highlights of LD 2167: The 175 day student year requirement is waived. All public employees will be paid through the budget year. If it becomes necessary to extend the 2020-21 budget process past June 30, that can be done. LD 2167 allows for school board meetings to be done remotely. [A board member asked if spring stipends are being paid. In the event there is no spring sports

season, spring coaching stipends will not be paid.] 4.) Mr. Tracy updated the board on the status of teacher contract negotiations. When school ended on March 13, the teacher negotiating team and board negotiating team were pretty much done, and it was the intention to have the deal ratified at the April board meeting. Events took over and the new plan is for both sides to have it wrapped up by the May board meeting. [One board member voiced the opinion that it makes sense to ratify a contract with the teachers at this time. She does not think that the existing (2017-2020) contract should be used as the basis for any new deal. Instead, she feels that the board should go to the association and re-examine everything that is done ie. salaries, insurance, teaching positions, etc. No other board members expressed agreement with those sentiments.] [Another board member asked about the budget process (whenever it resumes.) Will it be similar to what it has been in the past? A district-wide meeting, a referendum vote, etc.? Mr. Tracy said that the intent was to keep things as normal as possible.] [A board member expressed concern about students who may not have internet access at home. Mr. Tracy said that the district has attempted to contact all 6-12 families, and will be addressing this.] 5.) Discussing food deliveries, Mr. Tracy said that there are five pick up locations. There is also a call-in number, so that families who can't make it to a pick-up location can arrange to have food delivered. [A board member expressed concern, as she had seen on Facebook that one individual was unable to make it to a food delivery site. The board member was assured that people who make their concerns known have been helped.] Continuing with the topic of food delivery, Mr. Tracy said that food will be delivered to families each Monday, Wednesday and Friday until April Vacation week. In our region of the state, all schools are observing the scheduled April Vacation as a break from meals, packets, and online learning. 6.) Teachers in grades 6-12 have been trained in Google Classroom, Zoom, Screencastify, and other aspects of online learning. 6-12 families have been contacted regarding their internet access, and 40 hot spots have been purchased. These hot spots will be given to families that do not have internet access. 9-12 laptops will be made available to students this week, and 6-8 laptops the week of April 6.7.) Report cards will be mailed on April 10. [A board member asked if there is a plan in place in case - once sent home - student laptops are damaged or destroyed. The answer is there is a plan.]

Resignation: Lisa Savage - Reading Interventionist, Garret Schenk (effective at conclusion of 2019-2020 school year). [A board member asked if Lisa Savage's position will be filled. Mr. Tracy said that it will be. He mentioned Solon Fifth Grade and CCS Principal/6-12 AD as being two other positions that will need to be filled by the 2020-21 school year.]

Admin Updates: 1.) Tim Richards informed that board that as of April 6, Carrabec High School learning will be all digital. 2.) Jean Butler praised her staff for their hard work creating work packets and making food deliveries possible. 3.) Scott Hall and his staff are working hard making 6-12 computers ready for distribution. 4.) Lorie Agren said that she has a "great staff" and praised them for the work that they have done during a challenging time. 5.) Grace Cram says that her staff is working hard and praised the staff for their volunteer efforts. [A board member expressed concern about students with IEPs during this time. Grace responded that staff members are in regular contact with parents. The work the students receive is consistent with IEP goals. Tele-therapy is an

option for Speech and OT goals.] 6.) Brian Twitchell is impressed with the effort that staff members have made to learn new technology and their desire to make online learning work well.

Public Participation: The meeting was broadcast on Facebook and Youtube. Citizens were given a phone number they could call in order to ask questions. One caller asked if substitute teachers are eligible for unemployment. The caller was encouraged to contact state unemployment with that question. Another caller asked when the discussion of Garret Schenck would occur. The discussion will not occur until board meetings return to their "normal" form. A caller asked what towns should do as some of the towns are lacking in funds right now, yet they still need to pay the school district. The caller was told to contact the superintendent.

To see if the Board will approve the public proceedings, including school board meetings through remote access during "state of emergency". This was approved.

To see if the Board will approve the (draft) distance/remote <u>learning plan</u> The plan involves meeting basic human needs (food), making social and emotional connections, and helping educational needs. Educational needs are being addressed through learning packets and online distance learning. As time progresses, there may be a daily schedule put in place with real-time (live) classes. [A board member expressed the hope that we will document what is working well and what has not been so effective. She expressed concern with the 8:00 – 11:00 am "on call" hours for teachers, saying that does not work for some families. She suggested there be some evening hours where teachers were "on call".] [Another board member stated that she thought the k-5 packets were very effective. She was not sure how effective learning was at 6-12. She was particularly concerned about CHS students in "college classes", saying they needed more direction. The board voted to approve the (draft) distance learning plan.]

The meeting ended around 7:30 pm.

Now that I had a little time to take a breath, I have been sitting with what comes next. What comes next since nothing really changed since Easter, at least for the world we live in. We are still physically separated – distancing in love for one another, to contain this malignant virus spreading across the globe. What is different, is that Christ has risen. But, do we really acknowledge that? Has it really become a reality in our lives?

I have always loved the story of the persons walking to Emmaus. I am not really sure why, but in some ways the story resonates with me on a very deep level. And it seems strangely appropriate now, especially with so little change in our daily routines that brings us to awareness of the living Christ and the resurrection that took place just a few days ago.

See, these two people, were walking away; they were leaving behind the drama, the pain and the grief that they just experienced; they could take no more. 
Pray fully we will be back to more normal circumstances by this time next month.
