IMPORTANT REMINDER FROM THE DEPARTMENT OF INLAND FISHERIES AND WILDLIFE

IT IS A VIOLATION TO FEED THE DEER POPULATION FROM JUNE 1 TO DECEMBER 15

There are a few known spots of high deer traffic areas in New Portland where we are seeing a significant increase in deer/vehicle collisions; The State of Maine has put up signage marking those spots on Route 27 and Route 16. But there are many other locations on the secondary roads. Please assist us in keeping the traffic accidents down that involve the deer population by not feeding them. The local emergency services along with those involved in said accidents would greatly appreciate it.

Here are some known facts about feeding the deer population from Inland Fisheries and Wildlife's "Living on the Edge Winter Feeding of Deer: What you should know."

Feeding deer in late fall may disrupt deer migration to natural wintering areas. • Feeding concentrates deer in smaller areas reducing size and effectiveness of trail networks. • Concentrating deer in smaller areas can create a feeding ground for predators. • Concentrating deer in smaller areas may increase their vulnerability to diseases such as Chronic Wasting Disease. • Concentrating deer in smaller areas can literally kill all vegetation within their reach over one to several hundred acres, impacting regeneration and reducing the forest's ability to shelter deer in the future. • May cause long-term impacts on deer behavior as they lose their wariness toward people.

 Feeding sites near homes also place deer at greater risk of death from free-roaming dogs. • Feeding sites can significantly increase deer/vehicle collisions. • Deer may actually starve when fed supplemental foods during winter if they have a full belly of indigestible foods; many deer have starved to death with stomachs packed full of hay. • Providing inadequate amounts of supplemental foods can actually cause malnutrition in normally healthy deer populations. • Spoiled or moldy feed may be ingested and can be fatal. • Introducing a sugary diet to a deer used to eating a fiber-rich diet of browse can also lead to rapid death. • Deer compete aggressively for scarce, high-quality foods and only the strongest, most dominant deer (who would have survived the winter anyway) gain access to food, while deer most vulnerable to starvation in winter (usually fawns) are denied access to supplemental feed by more aggressive deer. • Deer may die from eating too much feed at one time. • Ending a feeding operation prematurely will lead to nutritional problems for deer that have become dependent on winter feeding, as will beginning a feeding operation too late. • Winter feeding is expensive; one deer requires 2 to 5 lbs of feed per day depending on the quality of feed.

The Town of New Portland is requesting written proposals from qualified Bidders for clean up at 54 River Rd. This includes furnishing all labor, equipment and materials required to satisfactorily and safely conduct all work to remove the debris left on the property from the controlled structure fire. The town reserves the right to accept or reject any or all proposals in whole or in part and to waive any informality the Town may determine necessary. The Town also reserves to itself the exclusive right to accept any proposals when it is deemed by the Town to be in its best interest. The Town is governed by Title 1 M.R.S.A. § 408-A, the Freedom of Access Law, which treats Bid Specifications as public documents. Selectmen's Meeting Minutes for August 7, 2018

Selectmen Present: Raymond Poulin, Andrea Reichert, Wayne Rundlett (arrived later in the meeting due to storm and fire calls). Present: Stacie Rundlett, Marilyn Gorman, Judi Wills, Michael Malesky, Chris Williams, Ray and Amanda Jordan, Becky and Gilbert Taylor, Mike Allen, Kristen Mitchell, Brayden Lovejoy

- 1. Andrea called the meeting to order at 6:30 pm.
- 2. Public Hearing:
 - a. The Board of Selectmen reviewed the information before them regarding the Bennett Hill Road property. The owner of the property, Mike Allen was not at the meeting as of this time. After reviewing the information and taking into consideration that there was not power due to a storm that had just gone through, the board decided to contact Mike Allen and schedule him to attend the next selectmen's meeting to discuss the property violations with him then.
 - b. The Board of Selectmen reviewed the information before them regarding the 48 River Road property violations. There were discussions on the clean up of the property after notice of a public hearing on the matter was sent out. The Board members discussed with Ray and Amanda Jordan their concerns with the violations issued on an annual basis. The Board members and Ray and Amanda had a discussion regarding keeping the property kept up as it has been recently to avoid future violation notices. It was agreed by the Board members that the property was currently compliant with the Junkyard Ordinance.
 - c. Mike Allen arrived to the meeting. He was on a fire department call in Salem. The Board members updated him on their earlier discussions of his property. Mike voiced to the Board members that he needed another month to finish cleaning up the outside of the property as well as the inside. There was a lengthy discussion regarding the conditions of the property and why there was a junkyard violation and a dangerous building violation. After a discussion and reviewing more information that Mike Allen discussed with the board, the Board members agreed to give Mike another month to address the issue properly. Mike agreed to contact Stacie once he did some cleaning inside of the home to have her document the conditions of the inside of the building. He stated that he would contact her when he was ready. The Board

- members stressed to Mike that all of the junk metals, debris, appliances and tires needed to be removed from the property within this month that they are allowing for him to complete his cleanup. Mike agreed to this and stated that he understood what they were asking of him. The matter will be revisited on September 4 at the selectmen's meeting.
- 3. Raymond motioned to accept the minutes as written, Andrea seconded and all were in favor.
- 4. Manager's Items: The Board members reviewed and signed payroll and accounts payable warrants. Stacie updated the board on the proposed timeline for the Wire Bridge Memorial Park. After a meeting with the park committee it was hopeful to have the parking lot and pathway paved and the tank for the bathroom facility installed later this year.
- 5. Department Heads:
 - a. Gary Agren updated the board on the status of damages from the storm that came through earlier in the evening. He also discussed with them that there is another beaver dam on Safford Road again. He updated the board on the status of the ditch work that has been done and what is scheduled to be done.
 - b Judi Wills shared with the board upcoming events and that the recreation committee was considering changing the name of the group.
- 6. Items by the Board of Selectmen: The Board began discussions with Gilbert Taylor regarding the snow plow contract. Becky Taylor voiced to the board members that she was very upset with the board because they backed out of a verbal agreement regarding purchasing Gilbert's sand/salt lot. Becky stated that the previous agreement on the amount for the snow plow contract was only because Becky and Gilbert were under the impression that the town would be purchasing their property for \$50,000.00, otherwise they would have asked for a higher amount to do the snow plowing. Andrea discussed with the group why she was reconsidering her thoughts on purchasing Gilbert's lot. Raymond also voiced to the group why he was reconsidering agreeing to purchase Gilbert's lot. They both shared with the group they were not totally ruling out that the town might purchase the lot, but felt it was crucial to look at all viable options and compare costs to do any site work and construction of a building. Currently, the property that the town already owns and the Fire Station and Town Office already set on could be another option to put a sand/salt shed facility. After a lengthy discussion regarding all previous agreements

and information regarding possible locations for a sand/ salt shed. Gilbert stated to the board that he was not willing to sign a contract for a one year term to plow the roads for anything other than \$265,000.000. The Board members were all in agreement that at this time they were not comfortable in changing the amount previously agreed upon of \$255,000.00 without further review and consideration of the amount. The board members and Gilbert and Becky Taylor continued to have discussions regarding the matter. After more discussions, Raymond proposed to increase the amount to \$260,000.00. Gilbert stated that he would agree to that and sign a contract for that amount. Stacie Rundlett voiced her concerns for the board and the amount and what she has already heard regarding the increase from the public. Andrea discussed with Gilbert some previous issues with two turn arounds and the complaints were thoroughly reviewed with Gilbert. Gilbert brought up a concern about some trees at other turn around locations. There were no other concerns with the contract. Andrea motioned to sign the 2018- 2019 snow plow contract with Gilbert for \$260,000.00; Raymond seconded and all were in favor. It was noted that all those signing the contract initialed the changes made to the contract made at this meeting. Andrea updated everyone regarding the animal control issues and dog licensing complaints.

Chris Williams discussed with the Board of Selectmen his concerns on a notice of violation that was sent to the owner of the property at which he resides. He stressed to the board that he felt he was being singled out and that he cleaned up the property last year and felt there was not an issue currently. There was a lengthy discussion regarding other properties throughout the town that were in violation of the Junkyard/Automobile Graveyard Ordinance and how many violation notices have been sent out and how many of them are repeat offenders and how many more are due to be sent out. Stacie and the board assured Chris that he was not being singled out and that there are a number of notices sent out, more to come and many of them were repeat notices.

Meeting adjourned at 8:04 pm.

Andrea called the meeting to order at 6:29 pm. Public Hearing:

a. Andrea briefed the public from beginning to current day some of the reasons the town was considering building its own Sand/Salt Shed facility. Lewis Wills updated all in attendance the scope of the Sand/ Salt Shed Project and the four estimates that were received for the ground work for said project. After a lengthy discussion the Board of Selectmen reviewed all of the information. Raymond motioned for the facility to be built on the town's property currently 911 River Road, Wayne seconded and all were in favor. There was no decision made regarding with which contractor to utilize. It was discussed to put specifics for the ground work in writing and resubmit to contractors to see if their prices still would be the same, and then the Board of Selectmen would decide with which contractor to utilize for the ground work.

Items by the Public: None Department Heads:

- a. Gary Agren updated the board on work done. He stated that the work was progressing well so far.
 Flailing will be done soon. There was a little shoulder was out on Freeman Ridge Road.

- c. Mike Malesky presented a supplemental tax bill to the board. The Selectmen reviewed the information and signed the supplemental tax warrant so a bill

- can be issued. Mike is also working on the Municipal Valuation Return and a couple of small abatements.
- d. Kip Poulin updated the board on some hose testing that had been done. He told the board that tanker two had been repaired and is now working fine. The board reviewed and signed payroll and accounts payable warrants. The board reviewed two treasurer's reports and signed off on them.

Items by the Board of Selectmen:

Andrea inquired with Mike Malesky if he could contact the engineer who has submitted a proposal for the sand/ salt shed building and see if he can attend their meeting scheduled for the September 12. Mike said he would reach out to him and see if it can happen.

There was a discussion on how things would proceed for deciding on a contractor to do the ground work. The board discussed that putting things in writing and contacting the contractor's that submitted estimates to see if their prices still would be the same. But putting things in a written document would be their next step. Agren discussed with the board that the town has the capability to build the road for the site themselves and save money there. The board thanked Gary for his information and would review all the options to keep costs to a minimum.

Dog License Reminder - New Portland Town Clerk's Office

Dear Dog Owner,

It's that time again! Please come to the Town Clerk's Office to license your dog(s) at your earliest convenience. Be sure to come in before January 31, 2019 to avoid paying the late fee of \$25.00 per dog. Any dog(s) that remains unregistered will be summonsed to court by the Animal Control Officer. So, please do not delay! These fines and deadlines are required by state law and cannot be waived.

Remember if your dog(s) is here for more than seven days, then you need to license your dog(s). If your dog(s) is six months or more in age then your dog(s) need to be licensed. In addition, if you no longer have your dog please call me at 628-4441 ext. 0 as soon as possible so that we may update our information.

To re-license your dog, you need to come to the New Portland Town Office. Our regular office hours are Monday – Wednesday 10:00 am – 5:00 pm, Thursday 12:00 pm – 6:00 pm. You may also re-license your dog through the mail. Please send a copy of the dog(s) Maine rabies certificate and a check payable to the Town of New Portland for the appropriate fee, and I will process the license and return the paperwork and the new dog tag(s) to you. *Please use the form provided on the next page if you are mailing your information in.*

Thank you for your attention to this important notice. Dog licensing ensures rabies vaccination, which protects the health of your pet and your family. Remember, all dogs in the State of Maine are required to be licensed. The fees are used to stop animal cruelty in Maine and to support our local animal shelter, which is located in Farmington.

The licensing fee is \$6.00 for neutered or spayed dogs and \$11.00 for male or female dogs *if licensed BEFORE January 31, 2019.* The fees will be \$31.00 for neutered or spayed dogs and \$36.00 for unaltered dogs *if licensed after January 31, 2019.* Please include a self-addressed stamped envelope with your copy of the Maine rabies certificate and payment to: Town of New Portland, 901 River Road, New Portland, ME. 04961

RSU74 / School Board

The September school board meeting was held on Wednesday, September 5 in a very warm CHS library.

Minutes: The minutes of the August meeting were approved.

Sports Presentation: RSU 74 AD Julie Richards and MSAD 59 AD Chris Leblanc addressed the board about athletic goals. They stated that increasing student opportunities and maintaining competitive co-curricular programs are their major priorities. Currently, boys' soccer, football, and cheering are collaborative efforts between Carrabec and Madison. In the future, if it becomes necessary to combine teams due to low numbers, it is hoped that the decision can be made well in advance of the affected sports season. Girls' tennis and golf are on the radar as being teams to be considered for collaboration, and girls' soccer has been discussed in the past. Some board members indicated that in the future there may be a philosophical question to be answered. Should the goal be to create teams or programs?

Superintendent Goals: Mr. Tracy outlined his academic goals for 2018-2019 - continue work with PBE and PBIS. (He expects to keep traditional GPA based diplomas.), make better use of academic data, improve the attendance rate in 2017-2018. There was an absentee rate of roughly 24% each day. He outlined operational goals for 2018-2019 - find efficiencies and cost-savings, continue with strategic planning.

Superintendent Report: Student enrollment has increased by ten students over a year ago at this time. It may be necessary to repair or replace the CHS bleachers.

An estimate showed that repair cost may be \$40,000 and a replacement cost may be \$70,000. A recent study asserted that Maine is one of five states with the greatest disparity in school funding between rich and poor districts.

Appointments: Sam Harper - special education ed tech 2, CCS/cross country coach, CHS; Andrew Ferrari - cross country, CCS; Tammy Long - yearbook advisor, CHS/after-school tutor, CHS; Joyce Flanagan - special education ed tech 2, GS; Billie Lawrence - special education ed tech 2 to Title One ed tech 2, GS; Heidi Day - girls' soccer, CCS; PJ Vicneire - boys' soccer, CCS; Eleanor Easler - bus driver; Debbie Brown - bus driver; Dave Dickey - part-time groundskeeper; Tony Pranses - after-school tutor; Victoria Burbank - second grade, GS (one year); Janet Boothby - Alternative Ed stipend.

Admin Reports: Tim Richards told the board that Homecoming Week is coming up. Tom Desjardins commended the CCS PTO, and mentioned a CCS Back to School Bash scheduled for September 15. Jean Butler gave dates of the upcoming Open Houses. (GS - September 25, and Solon - September 26). There is full enrollment in pre-K with 31 students. The new pre-K busing plan has gone well so far.

Committees: The Strategic Planning Committee met on August 17, and it will host a community event on October 26-27. The Policy Committee will meet on September 12.

Citizens: No one spoke.

Emergency Plan: The board approved updates to the RSU 74 Emergency Plan.

Ed Tech One, Garret Schecnk: The board approved adding an ed tech one position at GS.

A van: The board debated whether or not a van should be purchased. This agenda item was tabled until next month.

To see if the Board will transfer the below amounts to cover the over expended budget articles for 2017-2018.

Transfer out/reduce: special education (article 2) by \$60,000; student and staff support (article 5) by \$30,000; facilities and maintenance (article 9) by \$65,000. Transfer to/increase: CTE Instruction (article 3) by \$8,500; School Administration (article 7) by \$111,500; transportation (article 8) by \$35,000. This item was approved.

Huts and Trails: The board approved a CCS overnight trip (October 26 and 27) to Maine Huts and Trails.

Delegates for MSMA Conference: The board appointed two delegates to the conference.

The End: The meeting adjourned at 9:02 pm.
