Minutes for Selectmen's Meeting May 5, 2020

Selectmen Present: Raymond Poulin, Wayne Rundlett, Andrea Reichert; Present: Stacie Rundlett, (via Zoom) Brian Rundlett and Ron Sarner.

- 1. Call the meeting to order: Andrea called the meeting to order at 6:33 nm
- Review Minutes from previous meeting: Raymond motioned to accept the minutes as written, Wayne seconded and all were in favor.
- 3. Old Business-: There was none.
- 4. Department Heads: Wayne noted to the board that Kip was still looking at options for new turnout gear.
- 5. Items by the Public: There were none.
- 6. Items by the Town Manager: The board reviewed and signed payroll and accounts payable warrants.
- 7. Items by the Board of Selectmen:
 - a. The board discussed their options for the applications submitted for the Interim Assessor's Agent position. After a thorough discussion the board felt that Tom Walker would be best candidate for the position currently and asked Stacie to contact him and schedule an interview.
 - The board discussed the Winter Sand Proposal ad and decided to keep the amount of sand at 3700 cubic yards.
 The ad is to reflect bids to be received and opened at the July 7 selectmen's meeting.

- c. The board discussed an abatement request from Maine Timber Mats for 2018 and 2019 property taxes for (former business) USAccess. Former Assessor's Agent Audra Swanson assisted the board with this matter, and they reviewed her suggestion to not grant an abatement request, which was to deny due to the fact that an abatement request needs to be filed in a timely manner within 185 days per Maine State Property Tax Law Title 36 §841. They requested an abatement for both years on March 11, 2020.
- d. There was a discussion regarding the valuation on Nona Young's property and question about a high assessment. The board will be reviewing the matter prior to commitment and need to do a site visit.
- e. Stacie discussed with the board her proposal to have the office open normal business hours again. She suggested that they have a sanitation area outside of the office door, a plexiglass partition at the front counter, and only one person in the building at a time to keep everyone the six feet apart. After each person leaves the area and pens will need to be sanitized again before the next person enters the building.
- f. Andrea discussed with the board the need to review all documents from the engineer, specifically the field reports. Stacie would review all of her documents and have them available for the board.

RSU74 / School Board

The July school board meeting was held at Carrabec Community School.

Two new members joined the board: Danika Bates of New Portland and Larry Dunphy of Embden.

- To see if the Board will elect a chair and vice chair: Troy Dunphy was elected as chair and Bob Demchak was elected as vice chair.
- 2. Adjustments to the agenda: At the behest of board member Ellen McQuiston, an item was added to the end of the agenda. The new item was a discussion of teacher mentoring.
- 3. To see if the Board will approve the minutes of the Regular Board Meeting of June 4, 2020, the Special Board Meeting of June 10, 2020, and the Special Board Meeting of June 25, 2020: At the behest of board member Ellen McQuiston, the motion to approve all three meetings in one vote was changed to three separate votes, one for each meeting. The minutes of all three meetings were ultimately approved.
- 4. Presentation: There was no presentation at the July meeting.
- 5. Reports: Mr. Tracy told the board that he has been in numerous meetings which have dealt with the topic of reopening schools. He has met with local superintendents and the commissioner of education. There are more meetings to come. It seems most of the districts in the area are hoping to resume in-person education in the fall with a remote option. Mr. Tracy believes it is likely at the August meeting he will ask the board to approve this concept. A survey was sent to families asking for their feedback regarding distance education. To this point, there have only been 67 responses. The Budget Referendum will be held on Tuesday, July 14. Voting will take place from 8:00 am - 8:00 pm. Mr. Tracy encouraged everyone to vote. Teacher mentoring was discussed at this time. All new teachers (either new to the profession or new to the district) will have a mentor. In the past, there was one teacher mentor for the whole district. The plan for '20-'21 is to have a teacher mentor in each building. The teacher mentors will help new teachers as they become acclimated to the job, and mentors will facilitate professional development for the new teachers. Board member Ellen McQuiston expressed concern that each new teacher should have their own specific mentor that taught the same grade level and/or content.

Appointments: Chudala Holden - IEP coordinator; Grace Cram - 504 coordinator; Katie Hall - Advisory Dean, CHS; Candy Lebeau - Yearbook Advisor, CCS; Kim Cole - Yearbook Advisor, CHS; Jen Lachance - Lead Teacher, Solon; Dorrie Dunham - Lead Teacher, GS; Michelle Stevens - New Teacher Mentor, Solon; Stacey Robinson - New Teacher Mentor, CHS; Priscilla Ellis - New Teacher Mentor, CCS; Tanya Carey =-New Teacher Mentor, GS; Mary Keenan - Ed Tech Authorization Chair; Brian Twitchell - Certification Chair; Amy Price - ed tech 2 to ed tech 3.

Nominations: Lindsay Burke-Cinsov - District Music Teacher; Taylor Savage - Fourth Grade, CCS.

Admin Reports: Jean Butler commented on the summer Food Hubs, which are located at CCS, GS, and Solon. The

Good Shepherd Food Bank has once again donated food to RSU 74. Beth Higgins and Alicia Bedard organized the first Drive Thru Food Give Away, which was held at CHS on July 7. This was for anyone who lived in the district, not just families of students. 45 people attended. Amy Cates, Jessie Cates, Mike Golden and Alicia Golden helped with this event. Beth Higgins wrote a grant to obtain funding for homeless families. She was awarded \$5,000. Keith Mahoney has begun work as the new principal at CCS. Mahoney said that Somerset Public Health has contributed \$400 that will help go towards the creation of a sensory hallway. Brian Twitchell has been working with people from other WMEC schools. Together they are creating a certification handbook. The handbook will be adapted for use in RSU 74.

Committees: None met recently.

- 6. Public Participation: No one spoke.
- 7. <u>To see if the Board will approve Madison Health Center as the School Physician.</u> This was approved.
- 8. To see if the Board would like to state the Pledge of Allegiance at the beginning of every board meeting. This was approved.
- 9. To see if the Board will increase the Property & Casualty Insurance and Auto Liability deductible to \$1000 from \$500. This was approved.
- 10. To see if the Board will discuss the handbook changes. Last year, at the behest of board member Ellen McQuiston, some changes were made to the school/student handbooks. The board briefly discussed the 2020-2021 handbooks.
- 11. To see if the Board will discuss the ESEA application. Jean Butler gave an overview of the ESEA application. RSU 74 will receive \$472,000 from the federal government in 20-21.
- 11a. More Teacher Mentor Talk: This was the agenda item added at the behest of board member Ellen McQuiston. It appears that I did not take any notes during this agenda item. I do not recall that anything particularly different was discussed than during agenda item five, when teacher mentoring came up the first time.
- 12. Adjournment: I did take notes on this item. The board meeting adjourned at 7:22 pm.

A devotional from Rev. Rothea Kornelius:

PSALM 46:8-10

(The Message)

Attention, all! See the marvels of God!

He plants flowers and trees all over the earth,

Bans war from pole to pole,
breaks all the weapons across his knee.
"Step out of the traffic! Take a long,
loving look at me, your High God,
above politics, above everything."
We know this better as "Be still, and know that I am God..."

Having some time off this last week took me to Kennebunk. I had a lot of time to spend by myself. (I am not always sure if too much alone time is a good or a bad thing....). That meant a lot of time to hike, to think, to read, to be still... And if I am honest, I cannot remember when last I really did that.

I know that these past four months have been different for all of us. Some of us finding time to do the things that we have long set aside. Some of us beside ourselves with anxiety and worry, wondering when and if things will ever return to normal. And some of us had a double of our work load – being parents while working at home, taking responsibilities on to care for others. Our minds all the time running around non-stop.

This past week gave me a lot of silent time. It also made me realize why we don't dare sit still in silence long enough to have our thoughts and feelings bubble up inside us, and spending time in that mess. It is easier to keep busy and not pay attention - at least, it is for me. The reason being, when it all comes to the forefront, it is not always pretty.

What I also realized, is if we can sit in the stillness long enough, God shows up. God shows up when we are still long enough and give God space to enter. In that stillness, the soul that longs for God commune with God and are being fed. In that stillness, God shows up and shows us that we were formed in God's image, and with that, God is well pleased. When we are still long enough we find hope and courage, love and joy and a way into the future that is being transformed before our eyes.

So, this summer, also take some time to be still. Be still long enough not notice God again, to find joy in God's presence, to feel the love of God washing over you and caring for you. This summer, like Elijah, step into a place where God is in the stillness of the breeze. So turn of the radio or the TV, get of social media or the internet, put down that good book for a few minutes and sit still. Sit in complete silence and see if you can hear God inside yourself again - truly experiencing God and what God wants to offer you. Take 10 minutes, if that is you all you can stomach now, and open up and know that "I am God". You are enough, God loves you and care deeply for you. God wants to lighten the load and give you hope for the future. God wants some of your undivided attention to share all of this. So, I dare you - be still.... "Be still, and know that I am God."
