RSU 74 / School Board

The November board meeting was held at Carrabec Community School. The meeting began with the Pledge of Allegiance.

Adjustments to the Agenda: One item, to see if the board would approve the second reading of policy JIC, was removed from the agenda.

Minutes: The minutes of the October board meeting were approved.

Presentation: There was none.

Superintendent Report: 1.) The DOT has been in communication with RSU 74 regarding work that will be done on the Solon/Embden Bridge. 2.) To comply with federal/state regulations, RSU 74 will need to either show proof of COVID vaccination, or submit to weekly testing. 3.) Next week there will be no school on Thursday (Veterans Day) and a Workshop Day on Friday. Michael Chase "The Kindness Guy" will present. There will be a focus on "engagement".

Appointments: Jenny Rollins - After-School Program, Loren Soucie - Part Time Nurse, Kent Garland - Maintenance/Grounds

Resignations: (at conclusion of 2021-2022 academic year) Doug Larlee - CCS, grade 2; Priscilla Ellis - CCS, grade 7; Lynn Smith - CCS, ed tech 3

Admin Reports: 1.) Jean Butler told the board that the place settings had been created by Jazmyn Wagg's students. They were inspired by a discussion with Mr. Tracy, in which he stated

that he preferred big candy bars and also dressed as a biker for Halloween. 2.) The other administrators did not add to the reports they had previously submitted. 3.) When asked about sports, Athletic Director Erik Carey told the board seven students are interested in bowling. He asked Mr. Tracy to authorize a stipend for a bowling coach, and it has been done. The position has been posted. There continues to be interest in the idea of creating an E-Sports program. Board member Erik Ewing and Scott Hall have been involved with this from the tech standpoint. The start-up cost of such a program would be substantial. 5.) Board member Larry Dunphy reported that he had been contacted by people from Sugarloaf, and it may be possible to offer up a low-cost ski program for students in grades 4-8.

Committees: The Academic Sub-Committee met on October 13. Academic data was reviewed. It seemed desirable to look at CCS as two distinct entities with k-5 and 6-8 being analyzed separately. The science curriculum was discussed. The purchase of new middle/high school English-Language Arts textbooks is under consideration.

Public Participation: The next several pages in my notebook recap the public comments. Rather than recreate it all, I will be lazy and give a brief summary: The major topic was the agenda item to follow, which dealt with a mask mandate until January 5. Many spoke in favor of masks. Many were vehemently opposed. Also on the radar was the remote option. Some speakers faulted administration for not offering a remote option. Others were unhappy that synchronous learning was not taking place.

Masks Until January 5: Mr. Tracy explained his rationale for this agenda item was simply to keep kids in school. While he recognized that masking is a polarizing political issue, he was not looking at masking from that perspective. Under CDC guidelines, if masking is in place, fewer students need to be sent home as close contacts, and that was his priority. After much discussion, the board voted 8-6 in favor of masking through January 5.

Remote/Synchronous: After the mask vote, a new motion was put forward. This was to instruct Mr. Tracy to meet and consult with Carrabec Educational Association about the implementation of remote/synchronous learning. He stated that all through the spring, he and the board had operated with the belief that remote learning had been "less than successful in 20-21". Therefore, the push all spring and summer had been for "all students, all the time". It had been clear there would be no remote option in 2021-2022. (Note: here is a sentence | wrote in my June board meeting recap: He again expressed his belief that "Plan A" will be in effect in September, that is all kids, all the time, and no remote option.) Since there was no thought of having a remote option, synchronous learning had not been explored. In any case, after the lengthy mask debate, the board seemed to have come around to the view that remote, and even synchronous

learning was now essential. The motion to direct Mr. Tracy to meet with the Association to discuss remote and synchronous learning passed overwhelmingly.

A special board meeting has been scheduled for November 17, where remote and synchronous learning will be further discussed.

Executive Session, Superintendent Evaluation: This was the final agenda item.

Special Board Meeting: November 17, 2021

The special board meeting was held at CCS.

The meeting was a ninety minute affair; This meeting featured much discussion about remote learning, synchronous learning, learning packets, and learning platforms.

The one action was a motion to "direct the superintendent to provide updated progress on improvements for students in quarantine for remote learning access and to include synchronous learning."

The motion carried with only one person objecting.

The superintendent will report his findings at a December 15 special board meeting.


