2. The Board reviewed the minutes from the previous meeting. Janet motioned to accept the minutes as written, Raymond seconded and all were in favor.
3. Old Business: There was a brief discussion regarding Tax Acquired properties and the new laws that have been passed. No decisions were made.

All were in favor. Stacie would contact the previous vendor to get a new quote. e.) There was a brief discussion on FEMA and the status from the storms in 2023. f.) The Board discussed an emergency traffic ordinance to close the Tannery Bridge. It was motioned and seconded to do this all were in favor. g.) There was a brief discussion regarding a heat pump to be installed in the community room to help cool the room during warmer months. Half to be paid by the Fire Department and the other half from the Town Office. It was approved by the Board of Selectmen.

## RSU 74 / School Board

The board meeting was held at Carrabec Community School. It began with the Pledge of Allegiance.

Adjustments to the Agenda: An appointment was added, along with an executive session and an action item at the end.

Presentation: There was no presentation.

Superintendent Report: Mr. Campbell gave a few updates. There is a sinkhole at CCS that is about 24 by 30 inches, with an 18 inch drop. The temporary restructure of bus routes (moving to only seven) kicked off on March 6. The morning went reasonably smoothly. Mr. Campbell is planning to talk with the drivers on Thursday to see how the Wednesday pm run and the Thursday am run went. There will be a Policy Committee meeting on March 13 (6:00 pm), a Library/ Technology meeting on March 20 (5:00 pm), and the first budget workshop will also be held on March 20 (6:00 pm).

Robert Lightbody - CCS baseball volunteer; Troy Dunphy - CHS softball volunteer; Emily Witham - Long Term sub, Solon.

A board member asked whether it was necessary to pay coaches. Since we encourage students to do community service, she felt it might be better for adults to set an example by volunteering to coach. She also questioned whether it was right to have an employee "triple dip", receiving pay to teach, be athletic director, and coach.

## Superintendent RSU 74

**March 20, 2024**

Dear Residents of New Portland:

At the March monthly meeting of the Board of Directors, Christopher Roux was nominated as the Director of Operations. Mr. Roux's experiences include a community police officer, security officer for a bank, and most recently supervisor for a nursing home company. In his supervisory role, his department oversaw the running and upkeep of the buildings. Chris resides in Anson with his wife and two children.

On this day I will be reviewing with the full Board our proposed budget for the 2024-2025 school year. This is our last full year with federal money to support programs that are geared with assisting students in ELA and math on skills impacted during the disruptive school years due to COVID. The administrative team prepared a budget with all our current resources in the budget proposal which resulted in a two-digit increase to the local taxpayers. Reality is, that number was too much. We then discussed essential pieces necessary to support both the social emotional needs as well as the educational needs of our students. The revised budget has significantly reduced the increase to the local share. I will share more details in my April report once the Board has given final approval.

Our policy committee has been discussing at length the Board policy on Community Use of Facilities. Discussions have been on-going for two meetings as they attempt to balance our liability ramifications with convenience for use to our community members. Our next meeting is in mid-May.

## **MATE Housing Ministry** **A Program of Mission at the Eastward**

**WHO?** Volunteer Mission teams from all over the northeast come to Central Western Maine to share their talents and caring with area homeowners, who without assistance with labor and/or materials, would be unable to make needed repairs and maintenance to their homes. Many of the volunteers take vacation time to be here.

**WHAT?** Painting, roof repairs, porches, steps, ramps and simple interior and exterior repair are likely prospects for the teams. Wherever possible, we ask homeowners and families to participate in the work and its cost. At times the mission can help with materials through grants and donations.

**WHERE?** Currently we're serving mostly Franklin County: Farmington area, Chesterville, Jay, N. Jay, Livernore Falls, Wilton, New Sharon, Temple, Strong, New Vineyard. Somerset County: New Portland, Lexington, Highland Plantation & Embden. Volunteer work groups stay in North New Portland and Farmington, and we like to keep the work within 30 minutes of these towns.

**WHEN?** Volunteer Mission teams arrive during the months of June, July and August. The date and time the team will be at your home will be coordinated with you if your application is accepted.

**WHY?** The MATE Housing Ministry was created to help people in need stay in their home by doing needed repairs they could not otherwise afford to do. The volunteer Mission teams seek to do Christian service. They are called out of their everyday lives to serve in our community. They come to work on housing and would be pleased to work along with you. Their experience is made better by the time you share with them.

**HOW? If you own (or are buying) your home,** all you have to do is to fill out this application and return it. Each application received will be considered, and you will be contacted for further information if necessary. We'll call you to set up an assessment appointment, and we'll notify you, whether or not we are able to do the work requested.

**MATE-Housing Ministry** determines what applications are accepted based on the skill levels of the volunteer teams and the extent and complexity of the work requested. We do our best to prioritize the requests as to those most in need of assistance. We cannot guarantee that we can do everything requested, and it must be kept in mind that the work will be done by volunteers with varying skill levels. Whatever we do is done with the safety of the volunteers as our highest priority, and in completing a job to our mutual [client & MHM] satisfaction.

Mortgages held by other than a financial institution: In cases where the mortgage is held by other than a financial institution, MATE-Housing Ministry will require them to also sign off on any repairs made.
